Alternative Language Program - When Spanish is the Home Language Grades PK-6, Brick & Mortar

Grades 3-5, TVAH

Hallsville ISD is required to offer a Bilingual Program that aligns with one of the T.E.A. models of Bilingual Education. Because we do not have sufficient staff certification (staff with Bilingual certification in addition to their teaching credentials), HISD offers an "Alternative Language Program." Each year HISD submits a waiver to the T.E.A. for approval of such a program. Waivers are due November 1st of each year. HISD will be submitting a waiver for 2024-2025.

English as a Second Language (ESL)

Grades PK-6, Brick & Mortar - languages other than Spanish Grades 6-12, TVAH

Hallsville ISD is required to offer an ESL Program that aligns with one or more of the T.E.A. models of ESL, "pull out" or "content-based". HISD offers the pull out model for our students, as all RLA teachers that serve our students are certified in RLA and ESL. HISD has a support plan for teachers that are looking to obtain their ESL certification, including preparation time and reimbursement for the assessment. If an RLA teacher has not yet obtained their ESL certification, the student is assigned to the campus EB coordinator for services. Because each student is served by properly certified staff, HISD does not submit an ESL waiver.

Grades 7-12, Brick & Mortar

Program Descriptions

PK-12 ESL Pull-Out - Emergent Bilingual students receive intensive English Language development instruction from an ESL pull out/push in teacher. The amount and level of instruction is commensurate with the student's level of English language proficiency and academic achievement.

PK-6 Content-Based Sheltered Instruction -Instruction is designed to enable English Language Learners to become competent in listening, speaking, reading, and writing in the English Language through the integrated use of second language strategies. Instruction focuses not only on learning a second language, but also in using that language as a medium to learn math, science, social studies, and other academic subjects. A certified ESL classroom teacher delivers English Language Arts instruction and provides a level of ESL support commensurate with the students' level of English Language proficiency and academic achievement.

PK-12 Sheltered English - Instruction in all content areas is delivered by a teacher that is trained in sheltered instruction. Sheltered Instruction Observation Protocol (SIOP) Model is a research-based and validated instructional model that has proven effective in addressing the academic needs of English learners throughout the United States

PK-12 Teacher Assistant - Bilingual teaching assistant provides supplemental support in mathematics, science, social studies, and other academic subjects. The level of support is commensurate with the student's level of English Language proficiency and academic achievement.
