Vicksburg Community Schools received 3 proposals for 1 bid package that was solicited as Series 2 Release 1A, part of the 2020 Bond Projects on March 1, 2022.

B.P. 26.1- Electrical Improvements – 3 proposals Received (see attached Bid Tab).

Below is our final review, evaluation and award recommendation.

B.P. 26.1 – Electrical Improvements

The Bid Package Work Scope consists of: Removal of existing electrical gear and feeders from the existing boiler room to the existing transformer. Service Panels will be upsized to 3000A capacity to adequately supply future mechanical improvement needs as well as any future building improvements. Additional work associated with this project includes the replacement of the hollow metal exterior boiler room door and the interior concrete stairs in the boiler room. These stairs will be replaced with new metal grating stairs. An alternate to provide temporary power for a portion of the building that is expected to be under construction at the same time this service upgrade is taking place was also requested with this proposal.
