Approval of Competitive Sealed Proposals for Roofing Projects Detailed in the 2007 Bond Referendum and Roofing of Selected Portable Buildings District Wide

SUMMARY:

- This item requests approval of competitive sealed proposals submitted by CBS Roofing for Base Proposal for Borman Elementary, Base Proposal for Strickland Middle School including Alternate Proposal, Alternate Proposal Denton High, Base Proposal for Ryan High School including Alternate Proposal, and Alternate Proposal for portable buildings at Calhoun Middle School, Evers park Elementary, Ginnings Elementary, Ryan High School and Special Education Services totaling \$2,764,500.

Approve Competitive sealed proposals submitted by Castro Roofing for Base Proposal for Evers Park, Hodge and McNair Elementary Schools and Base Proposal for Fred Moore High School including Alternate Proposal for \$772,000.00.

PREVIOUS BOARD ACTION:

- Approval of the 2007 Bond Referendum.

BACKGROUND INFORMATION:

- The 2007 bond package includes \$2,756,150.00 for roof replacements of Borman Elementary, Fred Moore High School, Denton High School, Ryan High School, Calhoun Middle School and Strickland Middle School. Funds also exist for roof repairs/replacements in capital improvements to cover roof replacements for Hodge, McNair and Evers Park Elementary to finance the remaining projects' balance of \$780,350.00.

SIGNIFICANT ISSUES:

- CBS Roofing was ranked the highest by the Committee because of competitive pricing, including the entire scope of work and a discount for accepting all projects bid. The original bid from CBS Mechanical was \$2,799,500.00. After negotiations, the original bid was reduced to \$2,764,500.00. Castro Roofing was ranked the highest by the Committee because of their inclusion of the entire scope of work and a discount for accepting all projects bid. The original bid from Castro Roofing was \$782,000.00. After negotiations, the original bid was reduced to \$772,000.

FISCAL IMPLICATIONS:

Costs will be borne by 2007 bond funds.
 Roof replacements for selected portable buildings in the district will be funded by major maintenance funds appropriated for the 2008-09 school year. The Proposal submitted by CBS Roofing for this project totals \$63,000.00
