#### A. First Reading of Revised Policy IHAMB-E Abstinence Education

In March 2011 the governor signed HB 999 as passed during the 2011 legislative session. HB 999 requires each public school district to adopt either an abstinence-only or abstinence-plus education policy by June 30, 2012. The Tupelo Public School District has had policy IHAMB-E Abstinence Education in place since February 2000. Attached is a revised Policy IHAMB-E that brings the current Policy IHAMB-E into compliance with the requirements of HB 999. No action is requested at this meeting of the Board.

#### B. Second Reading of Proposed Revisions to Policy IJND for Inclusion of "New" Children's Internet Protection Act (CIPA) Compliance Information

Attached for second review, discussion, and consideration for adoption by the Board of Trustees are proposed revisions to TPSD Policy IJND Technology Resources: Responsible Access and Use. The Children's Internet Protection Act (CIPA) mandates that Policy IJND be revised and in place by July 1, 2012, to assure that it complies with new CIPA rules and regulations. Specifically, the Tupelo Public School District must document that Policy IJND (CIPA Policy) has been included as an agenda item and has been announced to the public via web page, etc.

In addition, the following tasks must be accomplished and/or TPSD Policy IJND must be amended to include the following information:

- Document that Policy IJND is approved by the Board of Trustees
- Assure that Policy IJND includes the following terms/phrases;
  - Technology Protection Measures are in place and used for all Internet Access
  - Monitoring of Internet usage for minors and adults is addressed in policy
  - Internet Safety Training is to be provided to minors and the following content is addressed in the policy
    - Appropriate online behavior
    - Cyberbullying awareness and response
    - Social networking sites
    - Chat rooms
