Name of innovative course(s): Firefighter I and II (N1256886 and N1256887)

Number of credits that may be earned: 1-3 credits for year one and 1-3 credits for year two.

Brief description of the course (150 words or less):

Firefighter I incorporates theoretical and hands on training to identify equipment, describe safety procedures, explore fire science and suppression, and analyze fire causes. Physical ability test procedures are also introduced. In Firefighter II, students continue the study of equipment, fire suppression, and fire protection. Rescue procedures, inspections, and reports and records are added to the study.

Essential Knowledge and Skills of the course:

This course will primarily follow the Basic Fire Suppression Certification Curriculum from the Texas Commission on Fire Protection in conjunction with the curriculum for Firefighter I and II at Odessa College (attachments pending)

Description of the specific student needs this course is designed to meet:

Firefighter I and II are courses designed to complete the Firefighter career pathway. The City of Odessa and Odessa Fire Department approached ECISD with the local need for this career pathway to fulfill a growing need for emergency service personnel with appropriate training. This need is coupled with growing student interest in emergency services pathways as viable career options.

Major resources and materials to be used in the course:

Upon course approval, the district will engage in a textbook adoption process per policy for Firefighter I and II. This course will also utilize the Basic Fire Suppression Certification Curriculum from the Texas Commission on Fire Protection in conjunction with the curriculum for Firefighter I and II at Odessa College. The district may also develop further curricular resources with the Odessa Fire Department and Odessa College.

Required activities and sample optional activities to be used:

Students in Firefighter I and II will engage in theoretical and hands on training to identify equipment, describe safety procedures, explore fire science and suppression, and analyze fire causes. Physical ability testing procedures are also introduced. Students also study equipment, fire suppression, and fire protection as part of field based experiences. Study of rescue procedures, inspections, and reports and records complete the two courses.



Methods for evaluating student outcomes:

Students will be assessed in their proficiency in the essential knowledge and skills through successful completion of the Basic Fire Suppression Certification Curriculum. Assignments, exams, projects, and field experience will all be components of student evaluation. The goal is for student eligibility for the Basic Fire Suppression Examination and readiness for EMT training.
