**RE: SB 100 Update**

**DATE: September 13, 2016**

Senate Bill 100, Public Act 99-056 was signed into law by Governor Rauner on August 24, 2015. The law will become effective on September 15, 2016. The new law made changes to the following sections of the School Code:

- 105 ILCS 5/10-20.14 (student discipline)
- 105 ILCS 5/10-22.6 (suspensions and expulsions)

Below is a summary of the steps taken to date to comply Senate Bill 100, Public Act 00-0456.

<b>February 8, 2016</b>	Provided Administrative Leadership an update on SB100
<b>February 23, 2016</b>	Provided Board of Education an update on SB100
<b>February -May 2016 and ongoing</b>	Worked with Diversity Council with ongoing staff PD on effective classroom management, culturally responsive and developmentally appropriate discipline and restorative justice
<b>March 2016</b>	Confirmed the Global Compliance Network (CGN) tutorial on bullying which specifically addresses SB100 requirement regarding student discipline/suspension provisions
<b>March 2016</b>	Obtained student voice on alternatives to out-of-school suspension via Middle School Advisory and Student Council
<b>March 2016</b>	Revised Notice of Student Expulsion administrative checklist and parent notification letters
<b>March 2016</b>	Revised Notice of Student Suspension letters
<b>May 10, 2016</b>	Board of Education Report on Second Step Curriculum
<b>May 24, 2016</b>	Board of Education approves purchase of Second Step Curriculum
<b>May and August 2016</b>	Communicated with District 200 and District 90 regarding their revised approaches to student discipline
<b>June 13, 2016</b>	Provided Administrative Leadership an update on SB100 led by Caroline Roselli and Emily Bothfeld from Robbins Schwartz law firm
<b>June 2016</b>	Updated Incident Management module in Power School to reflect revisions to Notice of Student Discipline letters

<b>July 12, 2016</b>	Board of Education reviewed revision of policies 7190, 7200, 7210 and 7220
<b>July 26, 2016</b>	Board of Education approved revision of policies 7190, 7200, 7210 and 7220
<b>August 2016</b>	Revised Student Behavior and Parent Handbooks
<b>August 2016</b>	Revised Student Behavior Intervention Record (BIR)
<b>August 25, 2016</b>	Staff training on Second Step implementation
<b>August –October 2016</b>	Principals will share information with families about SB100 via Open House, PTO meetings, and/or welcome back letters
<b>September 2016</b>	Second Step district-wide implementation of Second Step Curriculum
