NOTICE OF A PUBLIC MEETING/ NOTICE OF PROPOSED CONTRACT FOR LEGAL SERVICES

Notice is hereby given that a meeting of the board of trustees of <u>Joshua Independent School</u> <u>District ("Joshua I.S.D.")</u> will be held on <u>January 17, 2024</u> for the purpose of considering and taking action on all matters on the agenda for the meeting, including approval of an agreement with the law firm of Pearson Legal, P.C. as special counsel to perform all legal services necessary to recover damages, court costs, and penalties as provided in the Texas Insurance Code, the Texas Civil Practice and Remedies Code, and other Texas statutory and common law for breach of contract, violations of the Texas Insurance Code, and common law bad faith.

The agreement to be considered is necessary for recovering the unpaid <u>loss damages</u> ("damages") sustained by <u>Joshua I.S.D.</u> during <u>a hail/wind event on or around June 12, 2023</u>. By way of this agreement, <u>Joshua I.S.D.</u> seeks to recover damages, court costs, penalties, and other relief provided in Texas statutory and common law.

Pearson Legal, P.C., a San Antonio law firm specializing in insurance recovery and construction defects is fully qualified to represent <u>Joshua I.S.D.</u> in this matter.
