XVI. Approve Parent Transportation Contract: Motion by J. Black and seconded by K. Kissinger Wolf to approve the submitted Parent Transportation Contract. Motion carried unanimously.

XVII. Discuss Staff Survey Questions: W. Quesinberry proposed a change in the staff survey, to add (3) questions. The Board verbally agreed to add questions 5,6, and 7 from the options submitted by Mr. Quesinberry. No official vote was taken.

XVIII. Public Comment: There was no public comment.

XIX. Board Referrals: K. Kissinger Wolf informed the Board there will be several new policies as well as policy revisions on the February and March agendas. J. Black commented on her participation in a middle school parent meeting. No official action was taken.

Motion by D. Long and seconded by L.
