**RESOLUTION AUTHORIZING TRANSFER OF FUNDS FROM THE
EDUCATION FUND AND OPERATIONS AND MAINTENANCE FUND TO THE
TRANSPORTATION FUND**

WHEREAS, the Board of Education for Midwest Central Community School District No. 191, Mason and Tazewell Counties, Illinois, will be providing student transportation to and from school and leasing buses during the 2026-2027 school year; and

WHEREAS, Section 17-2A of the Illinois School Code (105 ILCS 5/17-2A) authorizes the Board of Education to make interfund transfers between the Educational Fund, Operations and Maintenance Fund, and the Transportation Fund; and

WHEREAS, Section 17-8 of the Illinois School Code (105 ILCS 5/17-8) authorizes the Board of Education to use funds in the School District's Transportation Fund for any transportation operating costs incurred for transporting students to and from school and school sponsored activities and the costs of acquiring equipment; and

WHEREAS, the Board of Education has determined that it is in the best interests of the School District to place the funds for funding the Transportation Fund as a means to better identify and isolate this funding source for the transportation costs; and

WHEREAS, the Board of Education has therefore determined that funds totaling \$500,000.00 should be transferred from the School District's Educational Fund to the School District's Transportation Fund and \$1,500,000 should be transferred from the School District's Operations and Maintenance Fund to the School District's Transportation Fund in order to fund District Transportation; and

WHEREAS, the Board of Education hereby finds and determines that it is in the best interests of the School District to transfer funds totaling \$500,000.00 from the School District's Educational Fund and \$1,500,000 from the School District's Operations and Maintenance Fund to the School District's Transportation Fund;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF
MIDWEST CENTRAL COMMUNITY UNIT SCHOOL DISTRICT NO. 191, TAZEWELL
AND MASON COUNTIES, ILLINOIS, THAT:**

Section 1. A transfer of funds totaling \$500,000.00 from the School District's Educational Fund and \$1,500,000 from the School District's Operations and Maintenance Fund to the School District's Transportation Fund for the purpose of funding the District Transportation Costs is hereby approved.

Section 2. The Superintendent is hereby directed and authorized to take all necessary steps to promptly transfer funds totaling \$500,000.00 from the School District's Educational Fund

and \$1,500,000 from the School District's Operations and Maintenance Fund to the School District's Transportation Fund during the 2025-2026 school year.

Section 3. This resolution shall be in full force and in effect upon its passage.
