Greetings Dr. Adams:

Thornton Township Youth & Family Services has been facilitating a successful after school program for at least 9 years. The specifics of the program have changed based on participants and culture.

This year, the program is planned as follows:

- Monday Thursday
- 3 hours (3:00pm 6:00pm)
- Homework help is priority
- Subject development (participants challenged in specific school subjects will get additional help when available)
- Physical development $(1-3 \text{ times a week, participants will be encouraged to exercise their bodies via sports and physical activities)$
- Culinary classes (1 4 times a month, qualified participants will have the opportunity to learn culinary arts @ a Thornton Township building)
- Mechanical Engineering classes (1 4 times a month, qualified participants will have the opportunity to learn basic mechanical skills @ a Thornton Township building)
- Junior Achievement classes $(1-4 \text{ times a month, qualified participants will have the opportunity to learn entrepreneurial skills)$
- Bi monthly field trips (during non-program and non-school hours, qualified participants will have the opportunity to be escorted on a fun/learning field trip)
- College Tour (In the spring of 2016 qualified participants in the $6^{th} 8^{th}$ grades will have an opportunity to take a college tour)
- Cost of the program (not including College Tour) is \$60
- Program runs October 13th 2015 May 13th 2016
- Targeted community is students in the area and Brooks School

Effectiveness:

- In previous surveys completed by participants and parents regarding our programs, approximately 2/3 of those surveyed reported better grades, more confidence in learning, and a better understanding of subjects
- Also, approximately 2/3 of those surveyed reported significant improvement in behavior
- Each year, we have a handful of former participants who have aged out of the program return to us and desire to be involved in the program due to how the program impacted them
- This year, we intend to collect more objective data regarding the effectiveness of the program

Expectations of District 152:

- To provide the program with ample space (this includes 2- 3 classrooms that will comfortably seat 30 participants, the gym and computer lab)
- To allow our supplies to be locked in a classroom (in and on top of a locked storage cabinet)
- To do a call blast to participants about the program
- To distribute provided flyers to students
- To provide instructors with a copy access code
- To allow registrations to take place at Field School
