The Center began utilizing Texpool to hold short term excess funds for investment. Texpool is a local government investment pool and as of March 31, 2016, the pool had total invested funds of \$16,145,100,336. The most recent information available (March 31) showed Texpool funds were invested in Agencies (69.7%), Treasuries (20.2%), Repurchase Agreements, (8.2%) and Government Money Market Funds (1.9%). The average daily interest rate for April 2016 is 0.3428%.

BBVA Compass Mutual Fund

The Center has established a investment account with BBVA Compass (the Center's Depository Bank) to invest some overnight funds in a Public Funds Money Market Mutual Fund. On February 1, 2016, the Center began using this account. Current interest rate is 0.15%.
