

Minutes of Special Meeting

A Special Meeting of the Board of Trustees of Terrell ISD will be held Wednesday, May 14, 2025, beginning at 11:30 AM in the Terrell ISD Boardroom at the Central Administration Building, 700 Catherine St., Terrell, Texas 75160.

The subjects to be discussed or considered or upon which any formal action may be taken are listed below. Items do not have to be taken in the same order as shown on this meeting notice. Unless removed from the consent agenda, items identified within the consent agenda will be acted on at one time.

1. Call Meeting to Order and Establish that a Quorum is Present
Ann McDonald called the meeting to order at 11:30 am. Monty Westbrook was present.
2. Pledges of Allegiance and Moment of Silence
The pledges of allegiance and a moment of silence were led by Ann McDonald.
3. Public Comments
There were no public comments
4. Consider/Approve All Matters Related to Canvassing the May 3, 2025 Board of Trustees General Election Including Adopting an Order Declaring Results of the Trustee General Election
Tonya Tillman presented the official election results for the May 3, 2025 Board of Trustees Election.

A motion was made by Ann McDonald and seconded by Monty Westbrook to approve the order declaring results of the May 3, 2025, Terrell ISD Board of Trustees Election as presented and approved unanimously.
5. Consider and Take Action on an Order Canvassing the Returns of a Bond Election Held in the District on May 3, 2025
Tonya Tillman presented the official election results for the May 3, 2025 Bond Election. VOTES FOR: 1453 VOTES AGAINST: 935.

A motion to approve an order canvassing the returns of a bond election held in the District on May 3, 2025 was made by Monty Westbrook and seconded by Ann McDonald and approved unanimously.
