1. It is hereby found, determined and declared that the primary election of the voters of this district, held on September 12, 2017, was in all respects duly and legally called and held.

2. At Large:

The clerk is authorized and directed to acquire and distribute such election materials and to take such other actions as may be necessary for the proper conduct of said general November 2017 election (including District One Candidates Kuehn and Loeffler-Kemp and District Four Candidates Johnston and Lofald, which did not have a primary election) and generally to cooperate with election authorities conducting other elections on that date. The clerk is further authorized and directed to cooperate with the proper city officials to cause ballots to be prepared for use at said general election.
