TITLE I

STUDENT ABSENCES AND EXCUSES

Daily attendance and punctuality are absolutely necessary for a student to gain maximum benefits from his/her educational experience.

Oregon school law supports the Board's view, and restricts excused absences to illness of the student, student medical or dental appointments (confirmation of appointments may be required). Illness in the immediate family which requires the student's presence at home, when the tenets of the student's religion require an absence for religious observance of a holiday or emergency situations that require the student's absence. All other absences must meet the approval of the school officials or be treated as unexcused absences. An absence that does not meet the criteria of an excused absence, but has been confirmed by the parent will be marked as a "verified" absence.

Absences will only be excused or verified if a phone call is received from the parent/guardian the day the student is absent or a note received in the school office not more than 3 days after the child returned to school.
