The Facilities/Construction Department committee has reviewed all proposals received for *CSP 083-2015 Site Improvements for Various Campuses Project*. Based on their qualifications and best value offered to the District, we recommend that this project be awarded to the highest ranked General Contractor Leyendecker Construction of Texas, Inc., in the amount of \$503,463.00 (Includes \$50,000 allowance).

The original proposal amount received from Leyendecker Construction of Texas Inc., for Site Improvements for Various Campuses was in the amount of \$519,700.00. A voluntary price reduction was submitted in the amount of \$503,463.00 (\$16,237 reduction), without modifying the construction plans and specifications.

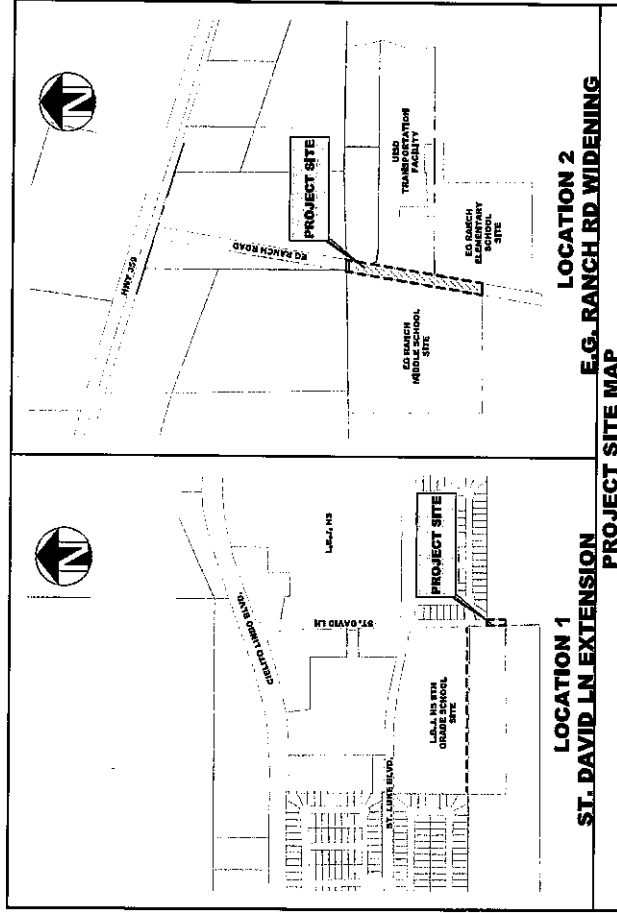

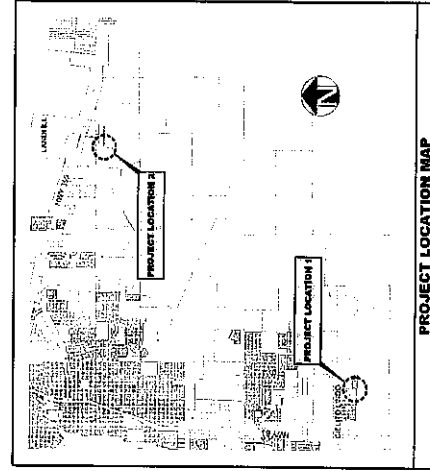


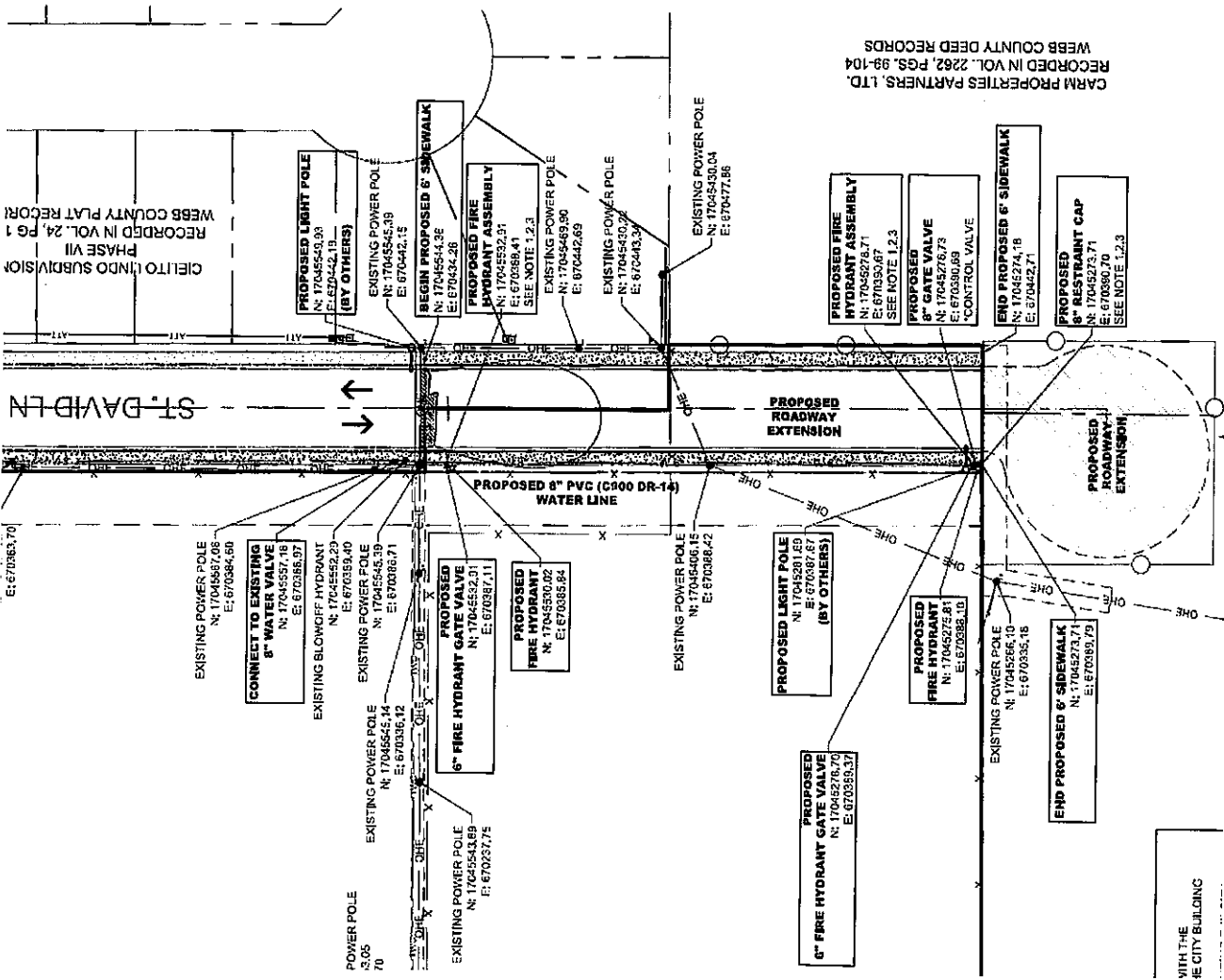
