Dear Mr. McGlathery:

On January 13, 2025, we received from you the following request for records pursuant to the Freedom of Information Act ("FOIA"):

My son Jackson is a student at Park View. I would like to make the following FOIA requests for the date of Friday January 10th :

- All phone and email to the Main Office, Rossana D'Amore, and Oscar Suarez on January 10, 2025
- CCTV footage from 11:00 AM through 2:30 PM of all interior cameras
- Phone records of any calls to phone number 630-330-5002

Please be advised that your request would constitute an undue burden on the District; compliance with your request would unduly burden the District's operation, for the following reasons:

- Your first request item asks, in part, for "all phone and email to the Main Office." This item is categorical and unqualified, and does not specify a particular "main office." We accordingly must construe this item as pertaining to the entire District. This item accordingly encompasses a sizable number of records; the District would be required to expend hundreds of hours to determine the responsive nature of each individual record, further assess any privacy or exemption concerns that may be present in each individual record, and make any necessary redactions.
- Your second request item for "CCTV footage from 11:00 AM through 2:30 PM of all interior cameras" is also unqualified and categorical, and does not specify a particular location. We accordingly must also construe this item as pertaining to the entire District. This item would require District staff to thoroughly review 3 ½ hours of footage from each interior camera in the District, confirm that the footage is responsive to your request, and assess any privacy or exemption concerns that may be present in the footage from each camera.
- Your final request item for records of "any calls to phone number 630-330-5002" does not specify a particular location or phone line, and is also unqualified and categorical. This request item would require the District to obtain records from both its office telephone service and its mobile telephone service providers (as these records are maintained off-site by our service providers) which, again, encompasses a sizable number of records. As is the case with the other records sought by your request, each of these records would then have to be reviewed to determine whether they include any calls to the number specified in your request, and to make necessary redactions to any records that may be responsive to your request.

The above-summarized endeavors would unduly burden the District's operations and the ability to conduct the business of operating the District. This burden outweighs the public interest in the records you have requested. Pursuant to 5 ILCS 140/3(g), you are respectfully requested to contact me before Monday, January 27, 2025 so that we may confer in an attempt to reduce your request to a manageable proportion.
