ADDENDUM TO THE AGREEMENT BETWEEN BROWNING PUBLIC SCHOOLS, SCHOOL DISTRICT NO. 9 AND GLACIER COUNTY TREASURER

It is hereby mutually covenanted and agreed that the following language shall be added and incorporated therein to the original contract between the parties executed on the 9th of January 2020 ("Original Agreement) as set forth in full: this addendum is in reference to sections 3 and 8.

3) a. County Treasurer: All revenue will be sent to the district investment account unless otherwise required by law.
