Re: Sale of Honda Outboard Motors

Commissioner Peterson,

In May of 2019, my office attempted to sale two 225 HP Honda Outboard motors that were removed from the sheriff's Safeboat. Attached to this memo is a copy of the request for bids. One bid was received and opened on May 8th with that bid only being \$800. This bid was taken to Full Board on May 21, 2019 with the bid being denied (see attached Board Action #15 dated May 21, 2019).

We have been actively trying to sell these boat motors and, recently, a bid was received from Timothy Robbins for the amount of \$5,000. I've spoken to Undersheriff Smith and Sergeant Ritter regarding this bid and both think it is a fair price. I am, therefore, seeking permission to sell the 225 HP Honda Outboard motors.

The Alpena County Sheriff's Office has 2-225 outboard motor for sale. These motors came off of a 2005 Safeboat and ran well when replaced. One motor is counter rotation and both have stainless props and 30 inch shafts. All wiring, shifters, and gauges are included. The motors were removed, winterized, and were shrink wrapped prior to being stored in a heated garage by a local dealer. Both motors are believed to be 2005, one has approx. 5000 hours and the other approx. 3500. The hours are not definite because the Alpena County Sheriff's Office was not the original owner.

Sealed bids must be received at the Alpena County Commissioners Office by 10:00 a.m. on May 8th 2019.
