

INTERLOCAL AGREEMENT BETWEEN

This Agreement, made and entered into by and between the Beeville Independent School District and Bee County, Texas, hereinafter referred to as "Beeville Independent School District" and the Bee County Commissioners' Court, a body corporate and politic under the laws of the State of Texas, hereinafter called the "County", as follows:

WITNESSETH

WHEREAS, the Beeville Independent School District is instrumental in providing services for the Citizens of Bee County; and

WHEREAS, the Beeville School District is in need of the assistance of the County in order to prepare parking lot 160' x 450' feet and the County's assistance in the form of equipment and manpower, which would not interfere with the County's work schedule and the costs incurred by the Veteran's Memorial Stadium Parking Lot are costs, which would be incurred regardless of whether or not the County participated in this project and said costs do not exceed \$14,620.20 and

WHEREAS, the Beeville Independent School District and the County find that it would be in the best interest of the citizens of Bee County and the Beeville Independent School District to enter into an Interlocal Agreement to cooperate together and accomplish Veteran's Memorial Stadium Parking Lot pursuant to V.A.T.S Articles 6702-1, Section 2.010 and 4413 (32e), **THE INTERLOCAL COOPERATION ACT**; nothing herein shall be construed to make either party a purchaser or consumer of goods or services from the other; nothing herein shall be construed to create any rights in the third parties.

NOW THEREFORE, in consideration of the mutual promises, benefits and covenants contained herein, the County and Beeville Independent School District, agree as follows:

I.

The County shall make a one time only contribution of manpower and equipment to reseal parking lot approximately 160 'x 450'.

II.

Beeville Independent School District shall pay the cost of fuel and materials and said costs shall not exceed \$ 14,620.20.

III.

The term of this agreement shall begin on the 23<sup>rd</sup> day of Feb. 2015 or before the project starts and on the day it is completed as provided herein.

IV.

Either party may terminate this Agreement, with or without cause, by giving at least ten (10) days written notice to the other party.
