2. ELL Newcomers Experience – Shonette Sims & Geneva Students
Shonette Sims shared information on newcomers to Geneva, who are defined as any foreign-born

Shonette Sims shared information on newcomers to Geneva, who are defined as any foreign-born student and their family who have recently arrived in the United States. There are four things we do

when we have newcomers: 1) we use welcoming practices to build relationships with the students and their families, determine students' assets, and acclimate students and families to the U.S. school system; 2) offer instructional supports to ensure culturally-responsive teaching, literacy skills and language development support, leverage students' assets and primary language, and utilize technology; 3) encourage family engagement to orient families to U.S. expectations regarding education, provide opportunities to support academic success, and receive referrals to wraparound services; 4) and we do monitoring and transition to ensure regular progress of content and language development, counsel students on their progress, and inform and adjust instructional placement and supports.

Geneva students from various grade levels shared with the Board their experiences as a new student to Geneva 304 from another country. One student shared that they came here in third grade and that the teachers were very helpful in their transition. They encourage Geneva students to include new students in their activities even though they may speak another language. A student who was born in Hungary also lived in Bulgaria and France before coming to the United States. They shared that their parents were a huge support in their transition, that Americans are friendly and open minded, someone was always willing to help, and that they found a new passion in photography. One student from Turkey was nervous moving to the United States, but said that you have to work hard and always ask for help. A parent whose family comes from Iran spoke on behalf of her kindergartener, who has only been in the United States for four months, saying that her son had a hard time adjusting, but is learning to speak English. There are not many immigrants in Geneva, but the community has still been supportive. They do not share the same culture, but they are willing to learn. A student from Singapore shared that it took them a few months to get to know the school better, but their grades are better here than Singapore. If they can boost their grades, then so can their classmates.
