Subject: Ellucian Banner - Oracle Database Licenses

Recommendation: Approve the Ellucian Banner Oracle Database Licenses for FY 2026

Background and Rationale:

The on-premise Ellucian Banner software requires the use of Oracle application software for data management. The current license is required to maintain our student information system server environment and support data warehousing needs from August 1, 2025 through July 31, 2026 covering the transition period for the Oracle SaaS migration.

The College is a member of the Texas Connection Consortium (TCC), which holds an Interagency Contract for Services for FY2026 with Lamar Institute of Technology (LIT). LIT holds a Master Agreement with Ellucian which allows TCC members to utilize that Interagency Contract to satisfy State of Texas bid requirements, as outlined in Texas Education Code 44.031 Section a, (4).

The license was budgeted for as part of the FY 2026 IT budget.

Underlying Agreement:	This Order Form ("Order Form") is issued pursuant to the 2022 Master Software, License, Services and Maintenance Agreement (the "2022 Master Agreement"), as thereafter amended, between: The State of Texas, acting by and through Lamar Institute of Technology ("LIT"), as successor-in-interest to Texas A&M University - Corpus Christi and as an institution of higher education of the State of Texas, for and on behalf of the Texas Connection Consortium ("TCC"); and Ellucian Company LLC ("Ellucian"). All terms and conditions of the 2022 Master Agreement are applicable to this Order Form.

This Order Form is made by and between **ELLUCIAN COMPANY LLC** ("Ellucian") and the TCC Member identified above. This Order Form will constitute a separate and independent contract between the parties hereto. Capitalized terms in this Order Form shall have the same meaning given to such terms within the 2022 Master Agreement unless redefined herein.

Licenses granted pursuant to this Order Form (if any) are for Client's internal use only, on Equipment residing within the United States, and are subject to all use restrictions and limitations set forth in the 2022 Master Agreement and this Order Form, including referenced attachments. Ellucian's grant of license(s) to Software may include (as applicable based upon the products identified in the table below) a non-exclusive, non-transferable license to use Software licensed on a perpetual or Term License basis and/or a non-exclusive, non-transferable license to access and use Cloud Software. Ellucian may use a combination of remote services, centralized services, and onsite services, using personnel worldwide, in performing its obligations with respect to Software Support Services, Professional Services and/or Managed Cloud Services identified in this Order Form. Where a number of hours is specified within this Order Form for Ellucian's delivery of Professional Services on a time and materials basis, the associated fees shown herein represent a good faith estimate based on the information available to Ellucian as of the Execution Date; the total fees payable for Professional Services may vary based on the actual number of hours required to complete the services and the rate that is applicable during the period of Ellucian's delivery of the services.

Software Term (applicable only to Software Support Services, Cloud Software, Software licensed under a Term License, Managed Cloud Services, and Modification Maintenance Services): The "Software Term" shall mean the period commencing on the Beginning Date(s) and ending on the Expiration Date(s) as such dates are identified in the table(s) below. No further action is needed from Client to terminate Software Support Services.

<u>Contract Year</u>. The term "Contract Year" means each period of twelve (12) months commencing on September 1 (or August 1, as applicable) during the Software Term.

Invoicing. Ellucian's obligation to provide credits (if any) under this Order Form is conditioned upon Client remaining current on all fees payable under the Agreement. As applicable based upon the specific products identified in this Order Form, Ellucian will invoice:

on an annual basis, in advance of each applicable Contract Year consisting of twelve (12) consecutive months
beginning August 1 during the Software Term for Term Software and beginning September 1 for Software Support
Services (fees for a partial initial Contract Year will be prorated as detailed in the Table(s) above).

Payment Terms:

- <u>TCC Contract Administrator Fee.</u> Pursuant to the terms of the 2022 Master Agreement and interagency
 agreement(s) between LIT and the TCC Members, LIT shall charge an additional 2% administrative fee to the TCC
 Member(s) pursuant to the terms of Exhibit E, which fees are not stated in this Order Form but are nonetheless
 recoverable by TCC from the TCC Member.
- <u>Term Software:</u> Ellucian will invoice LIT for the Term License subscription fees and LIT shall pay each invoice under the 2022 Master Agreement. The TCC Member will be invoiced by LIT for the annual Term License subscription fee amounts and shall pay each invoice to LIT in accordance with the 2022 Master Agreement.
- Software Support Services Including Maintenance:
 - (a) For the Software described in the Software Support Services Table above, Ellucian's obligation to provide Maintenance and LIT's obligation to make payment for such Maintenance shall each commence on the Beginning Date ("Commencement Date") and continue through the Maintenance Expiration Date specified in the Maintenance Table

above, inclusive. The Total Base Year Maintenance Fee stated above is the total that would be due from LIT for Maintenance fees for the initial full twelve (12) month period; however, if applicable, LIT shall pay a prorated portion of the Total Base Year Maintenance Fee to cover the Maintenance fees due hereunder from the Commencement Date through the end of the partial, initial Contract Year.

(b) Ellucian will invoice LIT, the Contract Administrator, for the Maintenance fees and LIT shall pay to Ellucian each invoice in accordance with the terms and conditions of the 2022 Master Agreement. The TCC Member will be invoiced by LIT for the Maintenance fees. The TCC Member shall pay each invoice to LIT in accordance with the 2022 Master Agreement.

<u>Publicity</u>. From time to time, in the ordinary course of business, Ellucian issues press releases and announcements regarding the completion of transactions with its customers and partners. As partial consideration for the products and services provided by Ellucian, Client agrees to provide Ellucian with reasonable and timely approvals of such press releases and announcements, including (where appropriate), the approval of quotations and acknowledgements to be included in such materials.

By the execution below, each party represents and warrants that it is bound by the signature of its respective signatory for this non-cancelable Order Form.
