This email is in response to the FOIA request received on March 5th.

For the 2014-2015 school year, the amount spent was \$35,075 for 285 participants.

For 2015-2016 school year, the amount spent was \$39,875 for 295 participants.

For 2016-2017 school year, the amount spent was \$40,975 for 300 participants.

These funds were used for staff to participate in low cost, high quality, professional development and administrative academics, aligned with district goals and initiatives. In the State of Illinois, teachers are required to accrue CPD's in order to keep their licensure up to date. Administrators must complete 20 hours of administrative academy credit for licensure requirements.

Parent Institute provides an opportunity for districts to pool resources in order to provide high quality educational opportunities. These are provided in English and Spanish for parents/guardians in communities which are under served and have high poverty.
