Status:

Seeking Board approval to enter into a contract with Convergint Technologies to migrate the existing district video system to Gentec Video in the amount of \$45,000. The funding sources will be the 501 construction account.

- \$41,275: Migration to Gentec Video that includes hardware, firmware updates, five (5) year contract for support (\$4,130 per year), travel, & labor.
- \$1,500 for remote training
- \$2,225 for contingency

Issue Summary:

The current Mototix security camera system is over 10 years old and needs to be updated. The software management system is out of date and very cumbersome to use. This creates delays in downloading footage and has resulted in missing footage. This project will update the firmware on all existing cameras, install a modern and robust video management system, access technical support for five (5) years, provide professional development, and integrate the new cameras that will be installed in the Facilities and CTE Buildings.
