Authority for this Action	Public Hearing of the 2023 – 24 Crosby Independent School District Annual Report as required by the Texas Education Code §39.306.
Goal/Objective Addressed	District Goal 1: College or Career Readiness Graduates of Crosby ISD will be prepared for success after high school by being adequately prepared for either college or work force success.
Background	<p>Texas school districts fulfill their legal responsibilities regarding the annual report of their educational performance and the Texas Academic Performance Report (TAPR) by holding an annual public hearing. (Texas Education Code (TEC), §39.306 and §39.362, or 19 Texas Administrative Code, §61.1022).</p> <p>TEC, §39.306, requires each district's board of trustees to publish an annual report that includes the PDF TAPR as well as the information summarized in the Annual Report.</p> <p>The PDF TAPR comprises the main part of the district's annual report, and it must be published in the same format as provided by TEA. Districts may promote the online reporting system as well, but the annual report must use the PDF TAPR.</p> <p>According to TEC, §39.306, in addition to the PDF TAPR, a district's annual report must include the campus performance objectives and the progress toward those objectives, information on violent or criminal incidents and prevention and intervention policies, findings that resulted from evaluations conducted under the Safe and Drug-Free Schools and Communities Act of 1994, information on the performance of the previous year's graduates in their first year of college as reported by the</p>

	<p>Texas Higher Education Coordinating Board (THECB) and the progress of the district and each campus in the district toward meeting the goals set in the district's early childhood literacy and mathematics proficiency plans adopted under TEC, §11.185; and college, career, and military readiness plans adopted under TEC, §11.186.</p> <p>As of December 2023, the PDF TAPR does not include, A–F ratings, Distinction Designations, or Special Education Determination Status.</p> <p>Statute requires that each district’s board of trustees hold a public hearing to discuss the district’s annual report within 90 calendar days of receiving the PDF TAPR. Within two weeks following the public meeting, each district must widely publish its annual report, including posting it on the district website and other public places.</p>
