As you know, CCATT/TACC/TCCTA have been working together with Sen Taylor and Rep Pacheco to advance SB 1230, relating to the establishment of the Texas Commission on Community College Finance. In addition to the commission, we are standing up an internal work group that will provide the commission with data and insight needed to make informed policy recommendations related to the community college funding model.
