OPENING OF MEETING

A moment of silence was observed. The pledge of allegiance and pledge to the Texas Flag were recited.

ACTION ITEMS

Discussion and possible approval of Policy EIAA (Local) revisions

Mr. Alphonso Bates presented information on Policy EIAA.

Dr. Nivens asked for clarification on if student absences that occurred prior to September 5, 2023 would count toward exemption eligibility. Mr. Bates stated that the Trustees can decide on when the start date for counting absences begins.

Dr. Nivens stated that when Policy EIAA was approved in 2002, students were required to come to school during exemptions, however, the student was exempt from having to take the final exam.

Trustees discussed the current EIAA Policy and options that campuses and principals could implement with the new revisions.

Mrs. Hotzel asked how the policy revisions would affect current students who are seniors. Dr. Nivens stated that the District has not addressed seniors as of yet.

Mrs. Danziger asked if the policy would apply to 7th and 8th grade students also. Mr. Bates said it would apply to junior high school students.

It was moved by Mrs. Danziger and seconded by Mrs. Hotzel that the Board of Trustees approve Policy EIAA (Local) revisions, as presented. The motion carried 6-1 with Mr. Welch voting against the motion.

INFORMATION ITEMS

Transportation and School Hours Update

Mr. Greg Buchanan and Ms. Sonya Cole-Hamilton presented information regarding school bus transportation and school hours.

Mr. Buchanan introduced Terry Penn with the Texas Association of School Business Officials who audited the 4-tier bell system and the compatibility with bus routes.

Trustees discussed some of the issues that have occurred regarding bus routes and possible options to address these issues.

Enrollment Management Update

Dr. Jon Maxwell, Dr. Marlon Waites, Ms. Cole-Hamilton and Mr. Buchanan presented information about the Lamar CISD enrollment management plan.

Dr. Brian Gibson spoke about the growth and enrollment at Morgan Elementary School.

Mr. Welch asked if Morgan Elementary School has the necessary teachers in place to account for the growth. Dr. Waites said Dr. Gibson has been working with Human Resources to address this.
