Re: Summer School Memo

Summer school 2013 data was presented at the December Quarterly Board Meeting. After reviewing the data, a team of administrators were formed to determine if our current framework is most beneficial for students. The team has developed the following recommendations:

Offer "Summer Adventures in Learning" (SAIL), a program similar to a summer day camp that would be available for elementary students who attend Title I buildings as well as current 7th and 8th graders. These day camps will feature a hands-on, theme based approach to learning and will be held at Windsor Elementary School (1-6) and Harlem Middle School (7 & 8). Harlem certified staff members will submit proposals for potential theme based units of study (proposal attached). The number of camps per grade level will depend on the number of teacher proposals as well as student requests. Although the themes will vary, all camp sessions will align to reading, writing, and mathematics standards. Pre and post assessments will document the progress of each student. Possible topics may include: art, science, tech ed, knitting, rockets, cooking, computers, drama, health and fitness. Minimum and maximum enrollment numbers for each camp session will vary depending on planned activities.

There will be no tutoring for students who attend Parker this year due to the low enrollment numbers in the past.

Extended School Year (ESY) for elementary students in grades 1-6 will continue to be offered at Windsor Elementary. Early childhood and kindergarten students enrolled in ESY will receive services at Parker Center.

The high school will continue to run a credit recovery program. Location is still being determined; the majority of the classes will be held at Harlem High School Ninth Grade Campus. Edmentum credit recovery program will be used when there are not enough students to fill a class. The high school will use pre and post tests to determine student progress. Summer School Driver's Education will take place at the Main Campus and will follow the Rules of the Road Curriculum and State guidelines.

SAIL (Summer Adventures in Learning) Camp 2014

We are excited to announce the Harlem Summer Adventures in Learning (SAIL) Program for summer 2014 and we invite you to participate! The SAIL program will offer hands-on, theme based enrichment choices for all students. Camp sessions can be two or four weeks in length, incorporating reading, writing and math common core standards in a multi-grade format (see attached proposal).

All camps will begin and end at Windsor Elementary School/Harlem Middle School but may include travel to other sites as necessary to complete camp projects/goals.

- Sessions run Monday – Thursday from 8am – 12 pm.
 - Two week session – 32 hours /student contact time (6/9-6/19 or 6/23-7/3)
 - Four Week Session – 64 hours/student contact time (6/9-7/3)

Students with reduced lunches during the 2013-2014 school year will pay \$100 per class.
