Dear Superintendent's Leadership Council and ECISD School Board,

One of our goals as music educators at Odessa High School is to provide our students with opportunities unique to their participation in our respective organizations. Thus, attached is our request for the Odessa High School Band and Choir to travel to Orlando, Florida June 4-8, 2012.

The trip will include three days in the Walt Disney World Resort and one day at Universal Studios Island of Adventure. The merit of music education will be reflected in the band and choir's participation as part of *Disney's Magic Music Days*. The band will participate and perform in a Disney "You're Instrumental" workshop with professional conductors in one of the Disney parks.
