On this 16th day of February, 2004, the Board of Trustees of the Coppell Independent School District convened in regular session with the following members present, to-wit:

and Bruce Jensen, Member absent, constituting a quorum and among other proceedings had by said Board of Trustees were the following:

WHEREAS, the terms of office of Deena Reeve, Place 2, Dianne Miller, Place 1, and Mike Arthur, Place 3, Members of the Board of Trustees of this school district, will expire on May 15, 2004, or when their successors are duly elected and qualified; and

WHEREAS, on the 15th day of May, 2004, a Trustee Election will be held in said school district; and

WHEREAS, Bruce Jensen has submitted his resignation as a member of the Board of Trustees, effective February 16, 2004, creating a vacancy in Place 5 as of February 11, 2004; and

WHEREAS, on the 15th day of May, 2004, a special election to fill the unexpired term of the Place 5 position will also be held in said school district; and

WHEREAS, it is necessary for this Board to pass an order establishing the procedure for filing for and conducting said Trustee Election; and

WHEREAS, it is also necessary for this Board to pass an order calling for a special election to fill the unexpired term of the vacancy in Place 5;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE COPPELL INDEPENDENT SCHOOL DISTRICT:

- 1. That an election be held in said school district on May 15, 2004, for the purpose of electing three members to the Board of Trustees of said school district, one member in Place 1, one member in Place 2, and one member in Place 3, and that a special election also be held on May 15, 2004, for the purpose of filling the vacancy created in the unexpired term of Place 5.
- 2. That all requests by candidates to have their names placed upon the ballot for the above mentioned Trustee election for Places 1, 2, and 3 shall be timely made in accordance with the law and shall be in writing, shall state the number of the position (place) for which such person is filing as a candidate, shall be signed by the candidate and filed with the Secretary of the Board of Trustees, School Administration Building, 200 South Denton Tap Road, Coppell, Texas 75019, not earlier than February 14, 2004 (91st day before election day) and not later than March 15, 2004 (61st day before election day). The office will be open until 5:00 p.m. on the date of the filing deadline.

All candidates shall file with said application the loyalty affidavit required by Section 141.031(K) of the Election Code.

The Secretary of the Board of Trustees shall post on the bulletin board in the building where the Board of Trustees meets the names of all candidates who have filed their applications in accordance with the terms and provisions of this Order.

3. That all requests by candidates to have their names placed upon the ballot for the above mentioned Special election for Place 5 shall be timely made in accordance with the law and shall be in writing, shall state the number of the position (place) for which such person is filing as a candidate, shall be signed by the candidate and filed with the Secretary of the Board of Trustees, School Administration Building, 200 South Denton Tap Road, Coppell, Texas 75019, not earlier than February 17, 2004 (the first day following order of the special election) and not later than April 14, 2004 (31st day before election day). The office will be open until 5:00 p.m. on the date of the filing deadline.

All candidates shall file with said application the loyalty affidavit required by Section 141.031(K) of the Election Code.

The Secretary of the Board of Trustees shall post on the bulletin board in the building where the Board of Trustees meets the names of all candidates who have filed their applications in accordance with the terms and provisions of this Order.

4. That said election shall be held at the following places and the residents of the school district who reside in the designated areas shall vote at the polling place specified below:

The Election Judges will be appointed by the Dallas County Elections Department and the Election Judges may be changed and the polling places may be combined for some precincts, pursuant to decisions of the Dallas County Elections Department.

4. The polls at the above designated polling places shall on election day be open from 7:00 a.m. until 7:00 p.m.

- Bruce Sherbert is hereby appointed Chief Deputy Early Voting Clerk, and 5. Ida Adams is hereby appointed Early Voting Clerk. The early voting for the above designated election shall be at the Coppell Town Center, 255 W. Parkway Blvd, Coppell, Texas 75019, and said place of early voting shall remain open for at least eight hours on each day for early voting which is not a Saturday, a Sunday, or an official state holiday, beginning on the 17th day (Wednesday, April 28, 2004) and continuing through the 4th day (Tuesday, May 11, 2004) preceding the date of the election. Said place of voting shall remain open between the hours of 8:00 a.m. and 5:00 p.m. on each day for said early voting, except on Sunday, May 9, 2004, when the polls shall be open from 1:00 p.m. to 6:00 p.m., and on Monday, May 10, 2004, and Tuesday, May 11, 2004 when they will be open from 7:00 a.m. to 7:00 p.m. Early voting by personal appearance may also be done during the same dates at the Dallas County Records Building, Office of the Elections Department, First Floor, 509 Main Street, Dallas, Texas 75202, and at any of the substations of entities taking part in the joint election. The Early Voting Clerk's mailing address to which ballot applications shall be sent and where persons voting by mail shall send their voted ballots is Dallas County Elections Department, Health and Human Services Building, 2377 N. Stemmons Freeway, 8th Floor, Dallas, Texas 75207. Persons voting by mail should sent their voted ballots to the Dallas County Elections Department.
- 6. In addition to the Board President and Vice President, Dr. Jeff N. Turner, Superintendent of Schools, is authorized to contract with the County of Dallas and the Commissioners Court, or any other agency, on behalf of the school district for the

carrying out of this election by the office of the Dallas County Elections Administrator in a joint election with other Dallas County governmental entities.

- 7. This Board of Trustees has determined that a direct record and optical scan voting system shall be used in the above mentioned election for early voting by personal appearance, by mail, and at the election on election day.
- 8. The manner of holding said election shall be governed, as nearly as may be, by the Election Code of this State, and the office of the Dallas County Elections Administrator shall furnish all necessary ballots and other election supplies requisite to said election.
- 9. Immediately after said election has been held, the Precinct Election Judges shall deliver the voted ballots in the locked ballot box and all election forms and supplies to the satellite counting station designated by the Dallas County Elections Administrator for that precinct, for eventual transportation to the Central Counting Station in the Dallas County Elections Department, 2377 N. Stemmons Freeway, Dallas, Texas 75207.
- 10. The early votes shall be counted on the day of the election by the Joint Election Early Voting Ballot Board appointed by Dallas County. The results of such early votes shall not be announced or made public until after 7:00 p.m. on the date of the election when such results shall be announced and made public together with the general results of the election.
- 11. The Board of Trustees shall canvass the votes of the May 15, 2004 Board of Trustees election for Places 1, 2, and 3 as well as the May 15, 2004 special election for the unexpired term of Place 5, on Monday, May 24, 2004 at 9:00 p.m. at the school district administration building.

- 12. If no candidate for a particular trustee position receives a majority of the votes cast for that trustee position, a runoff election for that position is required. The runoff election shall be held on June 19, 2004 between the hours of 7:00 a.m. and 7:00 p.m.
- 13. The Board of Trustees shall give notice of said election, and this combined Election Order and Notice shall serve as Notice for said election. The Secretary of the Board of Trustees is hereby authorized and instructed to post or cause to be posted said combined Election Order and Notice on the bulletin board used for posting notices of the meetings of the Board of Trustees. Said posting shall be made at least 21 days (April 24, 2004) before the date of said election.

The secretary shall also cause a copy of this combined Election Order and Notice to be published one time in a newspaper of general circulation in the county where the school district is located. Said publication shall be between not more than 30 days (April 15, 2004), and not less than 10 days (May 5, 2004), before the date of said election.

It is further found and determined that in accordance with an order of the Board of Trustees, the secretary posted written notice of the date, place and subject of this meeting on the bulletin board located in the central administrative office in this school district, a place convenient and readily accessible to the general public, and said notice, having been so posted, remained posted for the time required by law to precede the scheduled time of said meeting.

The above order being read, it was moved and seconded that the same does pass.
