

# 2016-17-2: STATE LEGISLATIVE PRIORITIES for DENTON AREA INSTITUTIONS of HIGHER EDUCATION

WHEREAS, the Denton Independent School District places great emphasis on the quality of education; and

WHEREAS, the Denton Independent School District proudly acknowledges the fact that the city of Denton is the home of the University of North Texas and Texas Woman's University, as well as being within the service area of North Central Texas College; and

WHEREAS, the Denton Independent School District recognizes the importance of higher education as not only a critical component for attracting and retaining quality professional career opportunities, but also major corporate investment for the entire state, and subsequently a year-round positive impact on the local economy.

NOW, THEREFORE. BE IT RESOLVED that the Board of Trustees of the Denton Independent School District does hereby:

- Provide adequate funding for coordinated mental health services that are planned, cohesive and monitored for effectiveness at the community level.
- Support prevention and intervention programs that make homelessness rare, brief and nonrecurring.
- Provide adequate funding for programs that serve children, adults and families who are victims/survivors of abuse and neglect.
- Ensure adequate regulation of predatory lenders in order to provide protections from aggressive and harmful lending practices.
