CONSIDER APPROVAL OF 2019-2020 CHILD AND ADULT CARE FOOD PROGRAM (CACFP)

Mr. Mahan reported that the Special Nutrition Programs (SNP) provides reimbursement for well-balanced, nutritious meals served to individuals enrolled in the Adult Care Food Program (CACFP). In Arkansas, CACFP is administered by the Arkansas Department of Human Services, Division of Child Care and Early Childhood Education, Special Nutrition Programs. Fort Smith School District will be reimbursed for required snacks provided to preschool children.

The administration recommended that the board approve to operate CACFP for the 2019-2020 school year.

SUMMER READING PROGRAM PRESENTATION

Ms. Cathey Ford, Intervention and Dyslexia Coordinator and Dr. Kellie Minton, Director of Student Achievement and Accountability presented information about the Fort Smith Public Schools Summer Reading Camps that were held at six locations across the district during the month of June, 2019. Targeted students included 2018-2019 5th/6th/7th grade students and 9th and 10th grade students. Instruction using the Lindamood-Bell Seeing Stars and Visualizing and Verbalizing programs was provided from 8:00 a.m. to 12:00 p.m., Monday through Thursday.
