#### SUPERSEDING DECLARATION REGARDING USE FOR COUNTY FAIRS

The interest in real property reserved by the Alpena County Agricultural Society in the Warranty Deed dated June 26, 1901, recorded with the Alpena County Register of Deeds at Liber 26, Page 126, is hereby superseded and replaced. Commencing with the date of this Declaration, the recently formed Michigan nonprofit corporation known as the Alpena County Fair Society (the "Society") shall have the right to the exclusive use and possession of the premises described on the attached **Exhibit A** for one week of each year, with such week being selected annually by the Society in its discretion, for the purpose of holding a county fair. Notwithstanding the foregoing, the Society shall not have the right to use or possess the following buildings, which are designated on the attached **Exhibit B**:

- A. MSU Shed
- B. Shed Near Merchant Building
- C. MSU Building
- D. Animal Control Shed
- E. Animal Control Building
- F. Caretakers House
- G. Truck Barn

In addition, the Society shall not have the right to use or possess the portion of the Merchant's Building (Building #12 in the attached **Exhibit B**) that is currently used as a maintenance shop.

This Declaration is made in exchange for the sum of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is acknowledged.


