Minutes of the September 24, 2007 Regular School Board Meeting

The Board of Trustees of the Coppell Independent School District, #057-922, met in a regular session on September 24, 2007 at 6:17 p.m. in the Board Room of the Vonita White Administration Building, 200 S. Denton Tap Road. The meeting was called to order by President, Kathie Gautille.

Scott Orr made a motion to adopt an ordinance setting the 2007 debt service tax rate at \$0.229 per \$100 of valuation. Anthony Hill seconded the motion. The motion carried 7-0.

Cindy Warner made a motion to adopt a resolution authorizing participation in Texas TERM/Texas DAILY local government investment pool. Susie Kemp seconded the motion. The motion passed 7-0.

Cindy Warner made a motion to hire Harner & Associates as the demographic consultant for Coppell ISD for the purposes of redistricting, provided the District can obtain and use the data. David Apple seconded the motion. The motion carried 7-0.

Bennett Ratliff made a motion to accept new hires for CISD professional personnel as per list presented. Susie Kemp seconded the motion. The motion carried 7-0.
