AGENDA ITEM: Consider Approval of Purchase of Student Chromebooks

PRESENTER: Brooks Moore, Director of Technology and Earl Husfeld, Chief Financial Officer

BACKGROUND INFORMATION:

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- The District was awarded \$857,500.00 from the Emergency Connectivity Fund (ECF) Program to purchase Chromebooks for students. The ECF is administered by the Universal Service Administrative Company with oversight from the Federal Communications Commission.
- The deadline for approving purchases to be paid with ECF funding is June 30, 2022.
- During the February 28, 2022 board meeting, the Board of Trustees approved the purchase of 3,150 Chromebooks using \$771,750.00 of the ECF funding.
- We are presenting for your consideration/action the purchase of an additional 350 Chromebooks using the remaining \$85,750.00 in ECF funding
- To ensure the best pricing and value, the District utilized the State of Texas Department of Information Resources purchasing cooperative to obtain this quote.

FISCAL INFORMATION:

The \$85,750.00 cost of these student Chromebooks will be paid from the Emergency Connectivity Fund (ECF) Program.
