She helps with behavior plans, intervention ideas, looks at data and finds specific things to help students succeed and knows how to connect with kids. Students noted she makes sure all students are included in activities and understands everyone's point. She embodies the culture that everyone is different, but *One Sand Ridge*.

Elementary Education Assistant Director Kirt Swalberg introduced the Riverdale Lion's Club for the Partners in Education Award.
