- Be <u>recognized</u> as a 501 (c) 3 non-profit charitable organization. Schools & government entities are also eligible.
   First time applicants must provide copies of by-laws, operating procedures and operating board structure, including a primary contact person and board treasurer;
- o Abide by the County of Alpena's accountability standards (attached) for nonprofit organizations;
- o Submit a fully completed application, including budget and budget narrative (May 1 or before);
- o Present your program/project proposal to the Youth & Recreation Committee, as scheduled;
- A copy of <u>Liability Insurance will be required by the County</u> if application is approved;
- Attend a mandatory Y&R Meeting on December 7, 2023 to fulfill your funding contract in order to obtain funding. Non-attendance may result in forfeiture of grant funds.
- o Complete a Funding Report (including photos) at the culmination of your project/program.
- All reimbursement requests must be received by January 15, 2025.

#### To be considered, grants must:

- Provide recreational benefits to citizens of Alpena County;
- Be typed on this application form and three-hole punched;
- o Contain the original 3-hole punched application and ten (10) additional 3-hole punched copies;
- o Provide estimates, quotes or other pertinent information that support your request:
- Be submitted on or before the deadline. Please do not submit grants that are drilled, spiral-bound or contain staples. Use of temporary clips, such as paper or binder clips, are permitted when submitting your application and its 10 copies. Most applications are submitted in large manila envelopes.

#### Additional information for applicants:

All millage monies are to be for Alpena County recreation activities and any recreational service or site development/improvement must be open and available to all Alpena County residents. Use of local vendors and Michigan-made products/services are encouraged.

Your Organization's Executive Director, Superintendent, or Top Official must sign the Budget page. Your organization's Contact Person listed on the grant will be responsible throughout the grant year for all questions & requests from the County for photos, funding reports, etc. Some application areas may be limited in space. If additional explanation is needed, please attach additional sheets for full explanation.

All applicants are invited, and new applicants are encouraged to attend a **Pre-Deadline Workshop** on Thursday, April 6, 2023 at 7:00 PM at the APlex. The County Government operates the jail, maintains rural roads, operates the major local courts, keeps files of deeds and mortgages, maintains vital records, administers public health regulations, and participates with the state in the provision of welfare and other social services. In addition, the County maintains and operates county parks and recreation facilities, the County Fairgrounds, provides E911 Services and provides for Emergency Management, runs the regional airport and administers programs for emergency and low cost home repair and Veterans Services.

#### ~ Program / Project Information ~

#### Describe the community need addressed by this program/project.

The current Plaza Pool facility has passed its 50 year mark and has served the students, residents and visitors of Alpena County well in its time. The general useful life of a pool is 20-25 years - and so this pool has performed well beyond its brief. The pool in its current condition no longer allows for a high school swim & dive team - and the club team (Thunder Bay Schooners) cannot host swim meets- as the pool depths do not meet MSHAA or USA Swim standards. The aging infrastructure is also prone to breakages and very difficult to maintain, not energy efficient and used very old technology in its filtration and ventilation systems. In addition to the pool, the community is need of more/additional recreation facilities, including but not limited to: more gym space for basketball and volleyball, better and more workout equipment, shallow water for senior water activities, infant and toddler swim lessons, and aqua therapy, larger and more space for the growing martial arts program(s), dance and yoga.

#### How did you determine that this need exists? Please cite statistics, if possible.

The current pool facility is now fifty years old and due to failing infrastructure has gone from a facility that is cost neutral to the County, to the County having to put extra funds into for repairs/maintenance and upkeep (\$55,000 in 2022). Despite a dip in usage during COVID, the usage of the Plaza Pool has been on an upward trajectory (with almost doubling its numbers in the first quarter of 2023 as compared to 2022). APS has committed to re-starting a swim and dive team in 2023 and is currently seeking a coach for the 2023-2024 season; the Schooner took over a dozen swimmer to the MTSL State Swim meet. In addition, the Pool Work Group has been told of the many additional sport and rec needs as they began exploring the possibilities of a new pool facility.

#### How will this program/project address this need?

This project will work engage with the public to determine the scope of all of the recreation and sporting needs of the community - currently and looking towards the future - and help design the best and most cost efficient expansion of the APlex to meet those needs. The first phase identified would be a new pool complex - with potentially 1-3 phases to follow with a renovation and expansion of the APlex facility/campus.

#### Who will benefit?

All of the residents of Alpena County will benefit. This new facility would also help attract new residents to the County to work, live and play - with a lovely sports and rec complex in the heart of Alpena. The APlex is easy access by car, bus and is just off the Alpena Bi-Path for walkers, bikers, joggers. This complex will also help attract larger sporting events to the area - with the capacity to host larger swim meets and other sporting tournaments.
