**Treasurer's Report:** Jim Downs reported that the PEF regular checking account balance as of September 30, 2014 was \$27,127.20.

Motion was made by Stupek and seconded by Carlson. All Yes.

After some discussion, a later motion was made by Dunseth and seconded by Carlson to move the balance of \$3,639.97 out of the Website & DVDs line item ledger into the PEF regular line item ledger as it sits at a \$0.00 balance right now. All Yes.

The funds in the Fundraiser IPAD2 line item ledger may also be moved into the Regular line item ledger in the future. There was some discussion about whether the Website DVDs line item ledger needs to be maintained. Dr. Lett will look to see if our business sponsorships are accounted for in that line item ledger.

- 3. Mini Grant Dr. Lett reported that he, Dennis Ishmael and Jesse Miller met to determine what Mini-Grants they would recommend be funded by the PEF. A list of all of the Mini-Grants proposals is attached to this report and should be

incorporated as part of these minutes. The report lists the Project Descriptors, Applicants, Submitting Building, Amount Proposed, Status, Amount Recommended for Approval and Reflection Received. It was determined that the SMART Board requests listed as items 1 & 2 in the amount of \$3,053 each would be funded by Title 6 funds the district has. After discussion, items 10 and 12 were still listed as Under Discussion. Dr. Lett and his committee will research these items and bring back for approval at the November PEF meeting.

4. Publicity – We currently have \$251 in tickets sold for the Google Chrome Book raffle. Tickets are to be turned in this week and the winner will be drawn at this Friday's, October 17<sup>th</sup>'s varsity football game at home against Vandalia.

## **New Business:**

Dr. Lett reported that the 1 to 1 Pilot Program is going well. We have had some connectivity problems but those are being worked out. Our next public showcase will include this program's progress.

Jennifer Holthaus is also looking into the Amazon Smile program and the possibility of generating funds for the PEF.

Dr. Lett reports that donor board name plates will be updated before the basketball season and before graduation each year.

Mike Trexler is on target to file appropriated 501©3 documents to maintain the PEF's status.
