FINANCE

1. <u>Update on State Energy Conservation Office (SECO) Grant</u>

Chief Financial Officer, Mr. Browning shared the amount of this \$200,000 grant from the State Energy Conservation Office will allow districts to replace interior and exterior overhead lighting, wall packs, and all other qualified lighting with high- efficiency LED lighting systems. Excel Energy Group has performed an energy audit within GISD facilities that will lead to a proposal including scope of work to consider.

2. Facility Use Committee Update

Athletic Trainer, Mike Carroll shared information over the Facility Use Committee. GKD (LOCAL) permits nonschool use of designated District facilities for educational, recreational, civic, or social activities when these activities do not conflict with school use or with this policy. In the spring of 2025, Graham ISD, under the direction of Mike Carroll convened a group of stakeholders to improve GISD procedures for managing facility usage. The goal of this committee was to develop guidelines that clarify district procedures and expectations regarding the use of facilities.
