1. Synopsis of Contractor's Work:

Portland Opportunities Industrialization Center and Rosemary Anderson High School (POIC+RAHS) will provide robust summer engagement services available to all POIC+RAHS students throughout the summer.

The students will be able to choose from an array of options offered at five separate locations (three existing POIC+RAHS campuses and two PPS campuses). All activities will be credit-bearing, and students will receive incentives and/or wages to participate, depending on which programming they choose. Activities will include internship opportunities, core summer school courses, credit-bearing enrichment activities, field trips, and more.

POIC+RAHS was founded to provide culturally specific workforce training and career placement services to counter discriminatory practices keeping people of color unemployed, underemployed, and unable to access wealth building opportunities.

POIC offers programming in these areas: Arts, Enrichment, Science, Technology, Engineering, Mathematics (STEM), Youth Employment, General Enrichment, Sports.

POIC has the capacity to serve 150 students

2. Performance Period/ Dates and Times of Service:

This Contract runs from May 10, 2022 – October 1, 2022

Goals: Increased academic achievement tracked via GPA and credits earned, increased sense of belonging among students served, increased understanding of the PPS reimagined Graduate Portrait attributes, improved graduation rates among those served, increased access to engagement and learning opportunities during the summer months, Increased access to a variety of wraparound support services during the summertime, decrease the number of future disciplinary actions.
