## Minutes of Regular Meeting Monday, March 24, 2025 The Board of Trustees SPRING BRANCH INDEPENDENT SCHOOL DISTRICT

A Regular Meeting of the Board of Trustees of the SPRING BRANCH INDEPENDENT SCHOOL DISTRICT was held on **March 24, 2025**, beginning at 6:00 PM in the Wayne F. Schaper, Sr. Leadership Center, Board Room, 955 Campbell Rd, Houston, TX 77024, with the following Board Members present: Lisa Andrews Alpe, Courtney Anderson, Caroline H. Item 10C7 – Dr. Wolfe explained that 10C7 is attached to academic instruction materials allotment funds, not professional learning contracts. Motion made by Trustee Perez and seconded by Secretary Mahan that the Board of Trustees approved the consent action item 10C7.

Motion passed by a 7-0 vote.

Item 10D – Student Support Services Executive Director Dr. Lance Stallworth will provide Multilingual Acculturation Studies course to the Board. Motion made by Trustee Perez and seconded by Secretary Mahan that the Board of Trustees approve with the exception of Multilingual Acculturation Studies for Newcomers and approve the Fundamentals of Real Estate and Occupational Safety and Environmental Technology I courses.

Motion passed by a 7-0 vote.
