To Whom It May Concern:

As part of the drunk driving legislation enacted by the State of Michigan in 1992, the Drunk Driving Caseload Assistance Fund was created (MCL 275.625h(5)) to promote the timely disposition of cases in which the defendant is charged with violation of section 625(1)(3), or a corresponding local ordinance. Those funds are disbursed by the State Court Administrator's Office on an annual basis to individual District Courts, calculated from each Court's OUIL/OWI and Drug Cases annual caseload report.

This Court's share of the Assistance fund this year is \$3,686.32. This money is to be deposited with the Treasurer of this County as the Court's local funding unit, for appropriation back to this court to carry out the purpose of the Act. The court also received \$289.71 for Drug charges, which is also to be deposited with the County Treasurer

The court will be using these funds for trainings, court room monitors for security, and any additional District Court needs.

The total amount of \$3,985.03 is to be deposited by the Treasurer into Line Item #101-286-544.545 as revenue and then into the Drunk Driving Caseload Equipment #101-286-977.000, for disbursement back to the District Court budget. This amount has been taken to the Treasurer on this date.

District Court is requesting that a meeting be scheduled with finance regarding this issue.


