Meeting Minutes

March 27, 2018

The Collin County Community College District ("Collin College," "Collin," or "District") conducted its work session and regular monthly Board of Trustees meeting on March 27, 2018, in the Board Conference Room 135 and the Board Room 139, Collin Higher Education Center, with Chairman J. Robert Collins presiding. Trustees in attendance were Dr. Collins, Dr. Stacey Donald, Mr. Andy Hardin, Mr. Mac Hendricks, Mr. Steve Matthews, Dr. Raj Menon, Mr. Fred Moses, Mr. Jim Orr, and Mr. Adrian Rodriguez.

WORK SESSION CALL TO ORDER

Chairman Collins called the March 27, 2018, Work Session of the Board of Trustees of Collin County Community College District to order at 5:30 p.m., in the Board Conference Room 135 at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069. In addition to board members listed above, attendees included District President Neil Matkin, Executive Vice President Brenda Kihl, Sr. Vice President of Organizational Effectiveness Kim Davison, Sr. Vice President of Academic, Workforce, and Enrollment Services Sherry Schumann, Chief Financial Officer Ken Lynn, and Chief Public Relations Officer Tom Delamater.

Chairman Collins reconvened the regular monthly meeting of the Board of Trustees of Collin County Community College District at 7:09 p.m. in Boardroom 139 and welcomed those in attendance. Trustees in attendance were Dr. Collins, Dr. Stacey Donald, Mr. Andy Hardin, Mr. Mac Hendricks, Mr. Steve Matthews, Dr. Raj Menon, Mr. Fred Moses, Mr. Jim Orr, and Mr. Adrian Rodriguez. Other attendees included District President Neil Matkin, Collin College administrators, faculty, staff, vendors, and community members.

Chairman Collins called on Shirley Harmon, Executive Assistant to the District President/Secretary to the Board of Trustees, to certify posting of the notice of the meeting.

APPROVAL OF THE MINUTES OF THE FEBRUARY 27, 2018, REGULAR MEETING OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES

On motion of Dr. Menon, second of Mr. Matthews, the Board of Trustees of Collin County Community College District unanimously approved the minutes of its February 27, 2018, regular meeting.

RECOGNITION OF SPECIAL GUESTS

Chairman Collins recognized students from the Leadership Development Institute classes of Professors Michael Rose and Judi Wohead who were in attendance at the meeting.

PUBLIC COMMENTS

No public comment was presented.

PRESENTATIONS

1. Recognition of Retirees on the Occasion of their Retirement. The service of two retirees, Bill Gidney and Judy White, was recognized by the Board of Trustees. Chairman Collins presented gifts to Mr. Gidney and photos were taken as President Matkin read the following information about each retiree. Ms. White was unable to attend the meeting.

Judy White retired on February 28 after working at Collin College for 30+ years. Prior to her work as the Telecommunications Analyst in the Telecommunications Department, Judy was a Student Assistant for Business and Engineering, and then spent five years as a full-time employee in the Continuing Education Department. As Telecommunications Analyst, she was an integral part of each new building and every new phone installed throughout the district. Ms. White approached her work with a kind heart and gentle spirit. Regardless of the situation, her patient words and expertise always created a happy ending.

Bill Gidney retired March 9. He first came to Collin College as a student in 1992. While attending school, Bill had a work-study job cleaning the black boards in all (24) classrooms at the Central Park Campus. He was employed in a temporary, full-time position in CPC's Plant Operations for 11 months until he was hired as a full-time employee in 1994. He remained in the position of receiving clerk for 24 years. Co-workers described Bill as a kind and caring man with a great sense of humor.

President Matkin said Mr. Gidney and Ms. White are true examples of employees who emulated Collin's Core Values of dignity and respect and integrity. We will miss their expertise and wish them the very best in retirement.

2. Racial Profiling Report – In the absence of Chief of Police Bill Taylor who was attending the Texas Police Chief's Conference in Galveston, Chief Financial Officer Ken Lynn delivered the following annual Racial Profiling Report to the Board of Trustees:

Police Procedure

- 100.6 Collin College Police Department's Racial or Bias-Based Policing Policy
 - Officers shall actively enforce state and federal laws in a responsible and professional manner, without regard to race, ethnicity, or national origin.
 - Officers are prohibited from engaging in bias-based profiling when making traffic stops, field interview stops, or initiating asset seizure and forfeiture efforts.
 - This policy is applicable to all persons, whether drivers, passengers, or pedestrians.
 - Officers shall conduct themselves in a dignified and respectful manner at all times when dealing with the public.
 - Two of the fundamental rights guaranteed by the United States and Texas constitutions are equal protection under the law and freedom from unreasonable searches and seizures by governmental agents.
 - The right of all persons to be treated equally and to be free from unreasonable searches and seizures must be respected.
 - Bias-based profiling is an unacceptable patrol tactic and will not be condoned.
 - The President or designee shall provide a complaint process so that students, employees, and other citizens may report violations of this policy.

- The President or designee shall provide public education regarding the complaint process in the form of bulletin board notices, website postings, student handbook notices, public presentations, and/or other forms of communication designed to promote public awareness.
- The chief of police shall disseminate written regulations to all members of the police department that strictly prohibit racial profiling; define acts constituting racial profiling; describe the complaint process by which individuals may file a complaint if the individual believes that he or she has been subjected to racial profiling; and require appropriate corrective action to be taken against a peace officer who, after an investigation, is shown to have engaged in racial profiling in violation of this policy.
- The written regulations shall comply with state law requirements regarding the collection of data regarding arrests and the annual reporting to TCOLE and this Board regarding the data.
- The chief of police or designee shall provide period training regarding this policy and the department's procedures regarding racial profiling. (Tex.Code of Crim. Pro. art. 2.131).

2018 Racial Profiling Report

Mr. Lynn said that in compliance with the Texas Code of Criminal Procedure section 2.131-2.138, the following report on the statistical data gathered by the Collin College Police Department from January 1, 2017 through December 31, 2017 was being submitted to the Collin County College District Board of Trustees for their information. The report identifies individual traffic stops by racial categories established by state statute, searches both consensual and non-consensual and arrests and citations resulting from these traffic stops. Data must also be collected on whether officers knew the race/ethnicity of the driver prior to making a traffic stop.

Texas Occupation Code 1701.164 requires the statistical data in this report be submitted to the Texas Commission on Law Enforcement. The Texas Code of Criminal Procedure 2.132 mandates all law enforcement agencies in the state develop and maintain a policy on racial profiling.

This chart depicts the data required to be collected by police officers during traffic stops including the race/ethnicity of the vehicle driver:

Mr. Lynn concluded the report by saying a comparison of traffic stops by Collin College Police Officers by race/ethnicity to the aggregate race/ethnicity of the Collin College population demonstrates no significant deviance that would indicate racial profiling by the police officers.

After a brief discussion regarding the kinds of citations and arrests, Mr. Lynn said he would get specifics and report to the board. He will also furnish information on the racial makeup of the police department.

2018-3-1 Personnel Report for March 2018

Discussion: The Personnel Report for March 2018 included 75 three-year faculty contracts, 58 faculty contract extensions, 46 one-year faculty contracts, one faculty appointment, 8 staff appointments, 5 promotions/changes, and 5 resignations/terminations.

Executive Vice President Brenda Kihl talked about the contract process for faculty who are on one-year contracts for the first three years. To be considered for a multi-year contract (three-years) the faculty member must undergo a rigorous process that is unique

to Collin College that includes student evaluations, self-evaluations, college service, professional development, and associate dean review, completion of a board report, and recommendation from the peer group Council on Excellence. Dr. Kimberly Harris, current Chair of Council on Excellence (COE), said that COE is a peer group elected by discipline so that the Council has a lot of breadth. She introduced members of COE who were present.

Dr. Kihl, as Chief Academic Officer, certified that all faculty presented for contracts and contract extensions are qualified under the SACS principles of accreditation to teach in their assigned discipline and meet Collin College's standards of excellence. She recommended board approval of the faculty presented in items 1a, 1b, and 1c.

On motion of Dr. Menon, second of Mr. Matthews, the Board of Trustees of Collin County Community College District unanimously approved items 1a through 1c of the Personnel Report for March 2018 as presented.

On motion of Mr. Moses, second of Mr. Orr, the Board of Trustees of Collin County Community College District unanimously approved items 1d through 1g of the Personnel Report for March 2018 as presented.

2018-3-2 Report Out of the Campus Facilities and Construction Committee and Ratification of Executed Electricity Supply Contract

Discussion: At its meeting on January 23, 2018, the Board of Trustees authorized the District President or his designee to monitor pricing offered by Retail Electric Providers and execute an electricity supply contract as deemed in the best interest of the District. The District's contracted energy consultant, Energy Edge, received pricing proposals from the Texas General Land Office ("GLO"), MP2, MidAmerican and TXU. The GLO provided the best value to the District with a rate of \$0.03884 per kWh for each kilowatthour of electricity. The electricity supply Retail Sales Agreement was executed on March 7, 2018, with the GLO. The contracted rate is effective May 1, 2019, through April 30, 2022. The estimated cost savings over the current rate for the three-year term is \$106,107.00.

Campus Facilities and Construction Committee Chair Andy Hardin reported that the committee reviewed the information regarding the electricity supply contract at its meeting on March 20, 2018, and recommended ratification of the action taken by the District President in executing the contract.

On motion and second out of the Campus Facilities and Construction Committee, the Board of Trustees of Collin County Community College District unanimously approved the ratification of the executed electricity supply contract.

2018-3-3 Report Out of the Campus Facilities and Construction Committee and Approval of a Contract with Conley Group, Inc. for Third Party Roofing and Waterproofing Consulting Services

Discussion: An RFQ was issued for qualified firms to provide third party roofing and waterproofing services, which included the evaluations of roofing systems and moisture intrusion surveys at existing campuses and facilities. The services also include the creation of a replacement/renewal report, which allows for prioritizing the replacement and repairs of existing roofs and moisture protection systems throughout the District. The staff recommendation for this third-party Roofing and Waterproofing Consulting Services is Conley Group, Inc.

Campus Facilities and Construction Committee Chair Andy Hardin reported that the committee reviewed the information regarding the contract with Conley Group, Inc. to provide third-party roofing and waterproofing consulting services at its meeting on March 20, 2018, and recommended approval of the contract.

On motion and second out of the Campus Facilities and Construction Committee, the Board of Trustees of Collin County Community College District unanimously approved the Conley Group, Inc. for third party roofing and waterproofing consulting services for existing campuses and facilities.

2018-3-4 Report Out of the Campus Facilities & Construction Committee and Approval of the Designation of the Construction Manager at Risk ("CMAR") Delivery Method for Construction of the Phase 2 Projects of the 2017 Capital Improvement Program

Discussion: Inasmuch as Collin College is a public junior college authorized under Chapter 130 of the Texas Education Code, the College is required by Government Code Section 2269.056 to determine, before solicitations for services are issued, which construction delivery method provides the best value for the College.

The Government Code authorizes six (6) construction delivery methods: competitive bidding (combines design, bid and build); competitive sealed proposals; construction manager-agent; construction manager-at-risk (CMAR); design-build; and job order contracting. Of the six authorized methods, staff believes the CMAR method will provide the best value to the College. Under the CMAR methodology, the services of the general contractor are divided into two distinct areas:

- (1) Preconstruction during which the CMAR acts as a consultant to the design team during the design development stage and works closely with the College and its architect to advise on constructability, materials choices and to offer expert cost estimation services to assure that the project stays in budget; and
- (2) Construction where the CMAR provides project administration services and supervises and/or performs the actual construction through subcontractors and/or its own forces while keeping the project costs within the guaranteed maximum amount approved by the Board of Trustees.

Selection of the CMAR to provide the above services is recommended using the two-step process as outlined in Government Code Sec. 2269.253. Using this process Collin College would identify finalists based solely on qualifications then, in step 2, evaluate additional information from those finalists including the CMAR's proposed fee and prices for fulfilling the general conditions. Then, on that basis, the CMAR that provides best value to the College would be recommended to the Board for each project.

Designation of the CMAR delivery method triggers the Request for Qualifications solicitations process for an Architect for each project, which is also a two-step solicitation as required by Government Code Section 2254.004(a) which states "In procuring architectural, engineering, or land surveying services, a governmental entity shall: (1) first select the most highly qualified provider of those services on the basis of demonstrated competence and qualifications; and (2) then attempt to negotiate with that provider a contract at a fair and reasonable price."

Beyond approval of the construction delivery method, the Board will approve selection of the CMARs and architects when the administration brings forward agenda items for:

- (1) Consideration of Approval of Project Assignments (Negotiate and Execute August 2018)
- (2) Consideration of Acceptance of GMP (Foundation & Site Work TBD)
- (3) Consideration of Acceptance of GMP (Facility TBD)

Additionally, Board involvement will occur on a regular basis via detailed monthly reports to the Campus Facilities and Construction Committee, Board information reports to be included in the monthly board agenda, and information available to the Board and public via a web portal.

Campus Facilities and Construction Committee Chair Andy Hardin reported that the committee reviewed the Construction Manager at Risk (CMAR) delivery method for construction of Phase 2 projects of the 2017 Capital Improvement Program at its meeting on March 20, 2018. The Committee recommended approval of the CMAR method for the 2017 Capital Improvement Program Phase 2 projects.

On motion and second out of the Campus Facilities and Construction Committee, the Board of Trustees of Collin County Community College District unanimously approved the Construction Manager at Risk (CMAR) delivery method for construction of the Phase 2 projects of the 2017 Capital Improvement Program.

<u>2018-3-5 Approval of Private Offers to Purchase Struck Off Properties</u>

Discussion: Private offers have been made on four struck of properties in Collin County.

Board members agreed that they want give local vendors an opportunity to bid. President Matkin proposed that local vendors be informed when cooperative agreements are up for rebid.

- 6. Mary Nguyen, the first Health Science Academy student to also graduate with an associate of science degree this past spring, has earned another great distinction. She was one of only 150 applicants out of more than 1,000 who applied to the Texas Tech Nursing Program to be selected for admission. Ms. Nguyen was an excellent student and was part of the EMT program while she was at the Health Science Academy.
- 7. Several Collin College basketball players earned All-Region and All-Conference honors in the North Texas Junior College Athletic Conference (NTJCAC), Region V of the National Junior College Athletic Association (NJCAA). In addition, Jim Sigona was named Men's Co-Coach of the Year and Jeff Allen was named Women's Co-Coach of the Year.

The Lady Cougars basketball team finished with an 11-3 conference record, going 26-5 overall and winning an NTJCAC Conference Co-Championship. The Collin men's basketball team finished second in the conference with an 8-4 record and went 21-10 overall, battling their way into the semi-final round of the NJCAA Region V Tournament.

In addition, eight Collin College student athletes have been named to the North Texas Junior College Athletic Conference All-Academic Team. Each recipient completed three semesters of college work with a minimum of 36 hours of courses that lead to a degree all while maintaining a cumulative grade point average of 3.25 or higher.

- 8. The Collin College Health and Safety Fair drew an estimated 600 people to Central Park Campus on March 9. The fair provided free health screenings and presentations on healthy eating, exercise options and other wellness activities to Collin students, employees and the public. - 9. Dr. Matkin said he traveled to Austin on March 21 and gave testimony before the Senate Higher Education Committee chaired by Senator Seliger, along with Victoria College President David Hinds. The Committee is considering the role the state should have in overseeing the approval and development of new higher education locations into geographical areas already served by existing institutions.

It was inexpensive entertainment that was well worth the money.

Trustee Orr thanked the students for attending the board meeting. He thanked Dr. Menon for wishing him well when he had the flu last month. Mr. Orr thanked the faculty for their work and the Council on Excellence for its process.

Trustee Hardin thanked the students for attending the meeting and said the board appreciated their attendance very much.

Trustee Hendricks gave appreciation to the students and everyone for being at the meeting. He commented on the Council on Excellence/faculty contract process saying it is unique and tells guite a tale.

Trustee Matthews congratulated the faculty and Council on Excellence and said he was very impressed with the process in his first time to experience it.

Trustee Moses thanked everyone and said Collin has a great culture of excellence. He said he is pleased to hear about different programs and how Collin College is reaching out and touching people. Mr. Moses said the college is an extraordinary asset to the community and that the faculty and staff represent the college and the board well.

Chairman Collins thanked Trustee Hardin and the members of the Campus Facilities and Construction Committee for their hard work.
