Ms. Elkins provided an update stating construction at the Dr. Hector P. Garcia-Memorial Family Health Center is moving along nicely. Roof is scheduled for completion by mid-July, interior work will also begin, landscaping and irrigation work has begun. Very pleased construction project is on track, budget, and schedule.

Demolition work at Christus Spohn-Shoreline has begun. Site work is underway for the new tower; also starting interior renovation work at the site.

A lengthy discussion regarding all medical resources and services and their orderly transition planning from the Memorial campus to Shoreline campus was held. It was also reported that both emergency rooms are in full operation at both campuses. It was mentioned that medical patients are not being admitted to Memorial campus. If patients need to be admitted they are transported by ambulance to either Spohn Shoreline or Spohn South depending on their medical needs.
