AGREEMENT AMENDMENT NO. 1

WHEREAS, the County of Nueces (“Client”), Nueces County Hospital District (“Hospital District”) and Correct Care Solutions, LLC, entered into an Agreement with the effective date of December 1, 2015, for Medical Services for Inmates at Jail Facilities and Residents at the Juvenile Center (RFP No. 2993-15);

WHEREAS, the parties now want to exercise the option as set out in Article 7.1 of the Agreement to extend the term of the Agreement for 1 year;

WHEREAS, according to the Agreement, Article 8, Compensation, optional year 4 term compensation rate will be \$3,339,556.00;

NOW, THEREFORE, Nueces County, Hospital District and Correct Care Solutions, LLC, in consideration of the mutual agreements contained in the original Agreement and additional time provided pursuant to this agreement do hereby mutually agree:

1. To exercise the renewal option of one (1) year as set out in Article 7.1 of the Agreement extending the termination date of the Agreement to November 30, 2019.
2. All other provisions of Agreement shall remain the same.
