W-E-M BOARD OF EDUCATION MINUTES REGULAR MEETING

Monday, August 23, 2021, 6 p.m.

The WEM Board of Education met in regular session on Monday, August 23, 2021 at the Waterville Building. The meeting was called to order by Board Chairman Gary Michael at 6 p.m.

Board Members Jon Bakken, Travis Bowman, Michael, June Rezac, Jay Schneider, and Jon Velishek attended the meeting. Jeff Stangler attended the meeting virtually. Also present at the meeting was Superintendent Joel Whitehurst. Principals Bobbie Jo Bastian and Dr. Jennifer Wilson and Activities Director Jeff Boran attended the meeting virtually.

Motion by Bowman and seconded by Schneider to approve the agenda. Seven members voted in favor - motion declared passed.

Motion by Rezac and seconded by Stangler to approve the Regular Meeting Minutes from June 28, 2021 and the Regular Meeting Minutes from July 26, 2021. Seven members voted in favor - motion declared passed.

Motion by Bowman and seconded by Schneider to approve the July Finance Report. The bills and payroll from the report were \$1,621,608.49, deposits were \$732,324.73, and transfers were \$2,352,000. Comments on the report included a payment of \$319,311.25 to Bond Trust Services Corporation for building bond interest payment, a payment of \$85,692.00 to Liberty Mutual Insurance for the 2021-22 property insurance premium, and a payment of \$68,707.17 to ISD #829 Waseca for the second half of the special education contract.

Seven members voted in favor - motion declared passed.

Motion by Bakken and seconded by Schneider to approve the special education contracts with the Waseca School District. Heather Harms and Linda Hullopeter presented information about the contract and the program. Seven members voted in favor - motion declared passed.

Motion by Rezac and seconded by Velishek to approve monetary donations. The donations included:

\$200 from the Elysian area Chamber of Commerce to the band program and a \$500 donation from the Elysian Firemens' Association to the football program.

Seven members voted in favor - motion declared passed.

WEM Principal Bobbie Jo Bastian and WEM Principal Dr. Jennifer Wilson presented the following report:

- We are excited to welcome our 13 new staff members to our Buccaneer family. Included are our newest hire, Mrs. Anne Joubert, who will be a speech and language pathologist.
- Back-to-School communications have been sent out with the exception of the high school open house. Construction details will be assessed and communication will be forthcoming to parents and students. Priority will be given to our incoming freshmen students and their orientation at the high school. K-6 graders will have entrance conferences again this year with their parents while junior high students will have a structured open house.
- New teacher inservice will kick-off our back-to-school events on Thursday, August 26. All staff will be back on Monday, August 30 for inservice meetings.

This donation will allow us to ensure that students lacking supplies will be taken care of. This donation included school basics like pencils, rulers, glue, paper, folders as well as backpacks, binders, and pencil cases. This donation will impact many students.
