After-school Care Guidelines

- A designated staff member of HMPS will attend to after-school care students.
- After-school care program is for PreK3 – 8th grade students.
- Parents need to sign students out daily.
- Only parent or those authorized by the parent on the authorization form will be permitted to pick students in the after-school care program.
- Parents are expected to be prompt when picking up their child.
- Students NOT picked up by the designated time will accrue an additional fee of \$1 for every 5 minutes after 5:30pm. Fee will be added to balance and are to be paid in full on the 1st of each month.
***Important:** HMPS has the right to call Child Protective Services, the local Police-Department, or related authorities for any student who is not picked up by 6:00pm.*
- Students not picked up on time after 3 consecutive times will no longer be allowed to remain in after-school care and fees paid will not be refunded.
- Students will not be permitted to continue in after-school care program if their child does not follow the rules. First warning will result/ Teacher conference. Second warning will result in the child not being able to return to after-school care.
- Students are **not allowed** to play with electronic devices in after-school care. These devices are expensive and we want to prevent any accidents.
- Balances are to be cleared 1 week prior to last day of school. If balance is not cleared, students will not be allowed to participate the following year in after-school care.

Expectations

1. Payment is expected prior to your child attending after-school care, in a timely manner as indicated in your contract. Payments not received on time will accrue \$5 fee per day until full payment is received. Monthly payments are due the 1st of each month.
2. If late fees have accrued from previous month and not paid in full by the 1st of the month, the student will not be allowed to stay in after-school care the following month.
3. The HMPS Student Code of Conduct will be applied during After School Care Hours.
4. Students will do their homework during after-school care prior to play time.
5. Students are to bring a book to read when homework is done.

Reglas del Programa

- Los alumnos(as) serán monitoreados por un miembro del personal de HMPS.
- El programa es para alumnos de PK3-8vo año
- Los padres deberán de firmar al recoger a sus hijos(as).
- Solo los padres o personas autorizadas por ellos podrán recoger a los alumnos(as) del Programa Después de Escuela.
- Los padres deberán llegar a tiempo a recoger a sus hijos.
- Los alumnos(as) que no sean recogidos a la hora establecida o antes incurrirán en un cargo de \$1.00 por cada 5 minutos después de las 5:30pm. Todos los cargos deberán de ser cubiertos a más tardar el primer día de cada mes.
***Importante:** HMPS tiene el derecho de contactar a servicios de protección infantil, la estación de policía local, o otras autoridades si un alumno(a) no es recogido a las 6:00pm.*
- Los estudiantes que no sean recogidos a tiempo después de 3 veces consecutivas ya no se les permitirá permanecer en el Programa Después de Escuela y no se les reembolsara los pagos.
- Si un alumno(a) no cumple con el reglamento del Programa Después de Escuela, la primera advertencia resultara en una conferencia con los padres. La segunda advertencia resultara en suspensión del programa por tiempo indeterminado.
- No se permitirá a los alumnos(as) que jueguen con equipos electrónicos durante el Programa Después de Escuela para prevenir accidentes.
- Saldo deben ser liquidados 1 semana antes del último día de clases. Si el saldo no se ha liquidado, no se les permitirá a los estudiantes participar el año siguiente en el Programa Después de Escuela.

Expectativas
