4.2 National Board Members Day – November 15, 2015

Dr. Mutchler thanked the Board members for all of their volunteer time they spend looking after the future of Geneva 304. He read the resolution for School Board Member's Day and presented each Board member with a certificate.

## 5. SUPERINTENDENT'S REPORT (Policy 1210)

Dr. Mutchler reported that American Education Week is coming up and there are lots of activities to honor the support of partnerships for American Education. The Board will be attending the IASB annual conference in Chicago next weekend. There are workshops at this conference to help Board members grow in Boardmanship, provide professional development, and provide more information about schools around Illinois. We also have Parent/Teacher Conferences coming up on the Monday and Tuesday of Thanksgiving week. We hope that parents have gotten into PTC Wizard and signed up for those conferences. The conferences help to strengthen our partnership between parents and staff. He asked Dr. Law to provide an update on our teacher evaluation process.

Dr. Law reported that it's been over five years since the performance evaluation PERA was signed into law, and a lot has changed through work and changes made on the teacher evaluation process. We are now in the last step of this process, which involves the inclusion of student growth data as a significant factor in the teacher evaluation process. We have a Student Growth Committee that has been meeting over the course of the past year. They have done a lot of work to shape that process. We now have, in compliance with the law, developed a Joint Committee, with equal representation of teachers and administrators that makes the decisions on the use of student growth measures in evaluation. Our teachers are working to create or find, and pilot assessments this year. It was mandated by law that the Joint Committee form by November 1<sup>st</sup> of this year. We are confident of where we are on this. Our goal is to be in compliance with the law and to make this process meaningful and manageable for everyone.

## 6. BOARD DIALOGUE TOPICS & PENDING ACTION CONSIDERATION

6.1 Boiler Replacement/Piping Replacement Project

Dr. Mutchler reported that the Facilities Task Force and the entire Board have communicated on the boiler issue, and he thanked those who committed their time to this project. We do have an outline of the project, and are recommending the replacement of the boiler pipe at this time.

President Grosso gave some background information on the project, which was discovered as needed last spring. The Facility Task Force took time to research both options before coming to this final recommendation. Scott Ney reported that the current boilers have been well maintained and that we should get another 6-10 years out of them. They are inspected on a yearly basis. The District is also currently conducting a scheduling and space study at Geneva High School.

Board comments, concerns, question: What is the life of a new boiler? (It is estimated at around 15-

20 years.) When will this project begin? (During spring break.) Is there any way that we can start accruing funds now to prepare for when we do have to install new boilers? (We could do this, but we would need to watch the fund balance in the capital projects account.)

Motion by Wilson, second by McCormick, to approve the replacement of the boiler steam line and the acceptance of the lowest bid, item 6.1. On roll call, Ayes, seven (7), Juby, Lamb, McCormick, Nowak, Stith, Wilson, Grosso. Nays, none (0). Absent, none (0).

6.2 Schedule Next Stage of Community Engagement with IASB Representative Dr. Mutchler thanked the Board for their attendance at a workshop that was held on October 24<sup>th</sup> with IASB on engaging the public. He is now asking for thoughts from Board members on how to proceed. The training provided by IASB was at no charge to the District as we were the first in the Kishwaukee Region to take part, and will continue to be free of charge if we want to pursue the next session. Thank you to Mary Stith for her work with the ISAB to make this possible.

Board comments, concerns, questions: Has there been any feedback from the Communications Task Force regarding this? (There has been a great deal of enthusiasm. IASB has been engaging and not just guiding us.) We need to take advantage of any free quality training that is available to us, and the sooner we move forward the better.) Is the Board comfortable with the Communications Task Force helping to identify opportunities? (Absolutely, we do need direction.) The Task Force will pursue this.
