CALL TO ORDER

Board Chair Kelly called the meeting to order at: 4:00pm and led the audience in the Pledge of Allegiance.

AGENDA APPROVAL

Vice-Chair Rossi made a motion to approve the agenda as presented. Member Camp seconded the motion, there was discussion from Member Nelson requesting to change the order of the agenda. BOARD WORK SESSION

- Training Video
 - The Board watched a training titled Public Meeting Do's and Don'ts presented by OSBA. This training is required once per term of each of the Board members. These minutes will serve as verification that Chair Kelly, Vice-Chair Rossi, Member Reece, Member Camp and Member Nelson have completed the requirement of this training for their current term. There was discussion after the training to inquire about prior complaints against the previous board. There was an opinion shared by Member Nelson expressing that he didn't appreciate the pronouns and did not have faith in the information OSBA presented.
- Policy IIA Discussion
 - A Draft of Policy IIA was presented for discussion. Vice-Chair Rossi discussed and provided additional points to selection criteria 7a (1) and (2). These items will be added to the policy and another draft will be brought forward in a first read. Member Nelson requested paragraphs around the protected groups be removed. There was discussion

about policy in general, and how those are brought to the Board. Members also discussed school clubs and the students have freedom to start or be a part of. There was discussion about library books in general. Vice-Chair Rossi suggested whatever policy we vote on be reviewed by legal council to ensure it complies with the law.
