Mr. RunningFisher called the meeting to order at 5:00PM

Corrina Guardipee-Hall is very supportive, and has ability to show intelligence that comes from the reservation. She supports BNAS department in everything. Rebecca Rappold shows kindness shows kindness to all. Has empathy in her way of approaching things which is critical for the restorative justice BPS is aiming for. Mr. Hall felt it is very important for BPS leader to have the name, she is guiding our children and our ancestors would want her to be brought into our community with a name. BPS Recruiting Videos 2023-2024: Superintendent Hall presented the recruitment videos that are on district website by Robert Hall and Drew Landry.

MQEC Membership Information Update 2024: MQEC membership is calculated by enrollment and BPS pays \$2,500 annually.

Laura Bush Grant Awarded: The Library Grant was awarded to KW Bergan for \$5,000.

Summer School Update: Dennis Juneau reported on Summer School hours and locations and stated that Eekahkiimaht will work with summer school. Based on student ratios, there are 40 positions for k-2, 56 3-5, 60 6-8, 120 9-12, plus 2 Sped TAs. And 1 nurse. Registration started Monday 6/7/2024, after that onsite registration begins 6/10.

Board discussion: Sandra Rivas stated the wind damage to the roof has been open for 3-years and each time someone has said they were submitting a quote for the work, they never come in. The insurance wants to settle at \$10,000. This person will go onto the roof and give a quote on the cost of the repairs and the insurance will cover the cost; this person can bandaid it or give the district a better quote. Reid Reagan stated that Maddox was to return to work on the roof and never did; Aluminum Products was to inspect and did not want to do the repairs and two locals were supposed to submit quotes but neither one has done it yet. Mr. RunningFisher asked if the district can take the \$10,000 and be done with it. Ms. Rivas stated if BPS accepts it, and it costs more, we won't get any more from the insurance but if we get someone to look at it for \$10,000 and submit a quote to repair it, the insurance company may pay the cost. The problem is over the gym floor and already leaked on the new logo; this company will do this right now, pull apart and look at it, then give BPS a bid. Insurance, Custodial and security will depend on the event, if it is an event for our students there is no cost but all others will pay. All new rates will become effective July 1, 2024 and those living in/on BPS facilities will be given notice.
