I. SUPERINTENDENT'S REPORT

A. Recognitions

- 1. Class of 2015 Recognitions Keevin O'Neill: Mr. O'Neill recognized the list of seniors who have achieved awards and their parents.
- B. Legislative Report: Supt. Glaes statement referred to the Governor's, the House, and the Senate budget proposals.
- C. Kindergarten Enrollment Update: Kindergarten enrollment is currently up from last year at this time.
- D. Special Education Millage: On May 5 a six year 1.5 Mil Special Education millage will be placed on the ballot with the intent to more fully fund the mandated special education costs throughout the county. Vicksburg now must pay \$500,000 out of the General Fund to pay unfunded Special Education costs.

II. REPORTS AND PUBLIC INQUIRY

- A. Business and Finance Report Steve Goss
 - 1. Budget Progress Report for the Month Ending March 31, 2015: Asst. Supt. Goss reviewed the budget progress report for March, 2015 showing total revenues of \$14,430,073; total expenditures of \$15,101,675; and deficiency of revenues over expenditures of \$671,602.
 - 2. Bond Project Update: Asst. Supt. Goss reported that year to date expenditures for the bond project have totaled \$1,997,025 leaving a fund balance of \$4,418,413.
 - 3. Best Practice Resolution: Asst. Supt. Goss reported that this is the third year to have the opportunity to apply for incentive funding for what the legislature considers best practice. The District has met all nine of the requirements. Mr. Goss is recommending approval of the resolution later on the agenda.
 - 4. Munetrix Fiscal Rating for Michigan Public Schools: Mr. Goss reported that Vicksburg was one 30 Michigan school districts to receive perfect financial scores from the Munetrix fiscal rating system.
 - 5. Custodial RFP Results: Mr. Goss stated clearly that he was reporting the custodial RFP results and was not making a recommendation to the Board at this time. The RFP was extremely comprehensive with seven bidders. Grand Rapids Building Services (GRBS) was the preferred vendor. Forty-one school districts (including Portage Public Schools) currently use GRBS. Staffing levels would remain the same, plus there would be a dedicated supervisor for VCS. All employees hired are subject to same background check as current employees. Savings total \$153,446. Mr. Goss responded to audience questions. The Board will have three options at the May meeting:
 - 1. No nothing Keep custodial services the same as current
 - 2. Outsource based on attrition
 - 3. Outsource all custodians

Mr. Goss stated that the District would continue to explore custodial cost savings and bring a recommendation to the Board at the May 11 regular board meeting.

B. Performing Arts Center Annual Report - Tim Fuller: Mr. Fuller reported that it was an outstanding year for the performing arts and stated that his goal is to have a facility that is used to its full capacity from meetings to musicals.

C. Audience: Bob Collins read a letter of appreciation to Vicksburg Schools after his retirement of 30 years employment with the District.
